DRAFT RESOLUTION _____

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE PUMP STATION “A” UPGRADES PROJECT TO R&G ENGINEERING, INC. PURSUANT TO SECTION 2-828 OF THE PROCUREMENT CODE AND IFB 2010.04.30 IN THE AMOUNT OF \$498,000 (FOUR HUNDRED NINETY-EIGHT THOUSAND DOLLARS); FURTHER AUTHORIZING AN APPROPRIATION OF FUNDS FOR THIS PROJECT.

WHEREAS, on April 30, 2010, the Procurement Division of Finance formally advertised the Pump Station “A” Upgrades Project Invitation to Bid (IFB) 2010.04.30; and

WHEREAS, on May 11, 2010, a non-mandatory pre-bid conference was held with five (5) prospective bidders in attendance of the eighteen (18) contractors and subcontractors who obtained bid documents from the Procurement Division of Finance; and

WHEREAS, on May 18, 2010, prospective bidders attended a scheduled site visit to Pump Station “A” located at 1590 Campamento Avenue; and

WHEREAS, on June 8, 2010; seven (7) responsive bids were submitted by: Southeastern Engineering & Contractors, Inc., ABC Construction, Inc., Metro Equipment Services, Inc., Gonzalez and Sons Equipment, Inc., Comtech Engineering, Inc., R&G Engineering, Inc., and Governor Construction, Inc.; and

WHEREAS, The lowest responsive responsible bid for the Pump Station “A” Upgrades Project was submitted by R & G Engineering, Inc. with their bid of \$498,000.00 (four hundred ninety-eight thousand dollars); and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, an appropriation of funds is hereby authorized for the Pump Station “A” Upgrades Project from the Sanitary Sewer Fund in the amount of \$498,000.00 (four hundred ninety-eight thousand dollars); and

NOW THEREFORE BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to award the Pump Station “A” Upgrades Project contract to R&G Engineering, Inc. pursuant to Section 2-828 of the Procurement Code and IFB 2010.04.30 and their in the amount of \$498,000 (four hundred ninety-eight thousand dollars).

Section 3. That an appropriation of funds is hereby authorized for the Pump Station “A” Upgrades Project from the Sanitary Sewer Fund in the amount of \$498,000.00 (four hundred ninety-eight thousand dollars).

Section 4. That all Resolutions or parts of Resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

Section 5. That this Resolution shall become effective upon the date of its adoption herein.
