RESOLUTION OF THE CORAL **GABLES** Α COMMISSION. AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AMENDED AND RESTATED MEMORANDUM OF UNDERSTANDING, SUBSTANTIALLY THE ATTACHED FORM, WITH STRATA AI, INC TO CREATE A PARTNERSHIP THAT DESCRIBES BOTH PARTIES ACTIVE INVESTMENT AND FOCUS IN THE AREA OF ARTIFICIAL INTELLIGENCE. **ESPECIALLY** THROUGH EDUCATION WHERE STRATA AI PROVIDE COURSES

**WHEREAS**, On December 12, 2020, the City of Coral Gables (the "City") and Strata IA, Inc. entered into a Memorandum of Understanding (the "Initial MOU") pursuant to which the parties agreed to mutually promote, educate, and collaborate on the subjects of Data Science, Decision Science, and Artificial Intelligence; and

**WHEREAS,** the City will select and submit one employee to take the Full Stack Artificial Intelligence course at no cost to the City and Raimundo Rodulfo, the City's IT Director, will speak at a minimum of one public event, and one internal STRATA.AI event to share his experience, advice, and comments on the state of Artificial Intelligence; and

**WHEREAS**, under the terms of this MOU, each organization is responsible for its own expenses;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

**SECTION 1.** The recitals and findings contained in the Preamble to this Resolution are adopted by reference and incorporated as if fully set forth in this Section.

**SECTION 2.** The City Manager is authorized to enter into an Amended and Restated Memorandum of Understanding, in substantially the attached form as may be amended by the City Attorney and City Manager to accomplish the will of this Commission, with the Strata AI, Inc.,

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
