City Manager Iglesias: Mayor, our Planning Director will be presenting this and by the way, we have considerable amount of outreach and I think it's a good plan, will bring in numerous alternatives and I think they will do a good job in really working with our residents at the Biltmore area.

Planning and Zoning Director Trias: May I have the PowerPoint please. I have a very brief presentation to explain the process. The consultant has divided the contract into three phases. Phase I is the analysis and the actual fine-tuning of the process that we need to do. Phase II is the public engagement which the Mayor earlier on explained in some detail is up to eight meetings with the community, several walking tours. And the idea is to come up with three major alternatives that are supported by the community; and then Phase III is to develop those three alternatives with some cost estimates, renderings, and the type of images that it will yield as a Commission to make a decision. So, the total amount is \$110,000, and you can see the breakdown in the three phases. The analysis, we had some of that already done by staff. The public engagement will include a video, also a website, a very significant outreach effort. I think that's probably the best way to describe this effort. And the images that I'm showing you are work from Dover Kohl for Coral Gables in the past, so they have worked with us in the past. They are one of the best firms in the nation, I believe by far one of the best, and they are also a Coral Gables firm. They are on Sunset, so it's a very good team. And these are some of the renderings the before and after, as I said, up to three alternatives and hopefully enough ideas that you'll be able to make a decision. So that's the proposal, and if you have any questions, I'll be able to help you.
