RESOLUTION NO. 2025-25

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE POLICE DEPARTMENT TO AUTHORIZE THE PURCHASE OF AMMUNITION FROM FLORIDA BULLET INC. AS A “SOLE SOURCE PROCUREMENT,” IN AN ESTIMATED AMOUNT OF \$61,256.00 PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, the Police Department has determined the need to purchase ammunition; and

WHEREAS, the specific type of ammunition being purchased is CCI-Speer and Federal cartridges, a product of Vista Outdoor; and

WHEREAS, the cost for the purchase of this ammunition is an estimated amount of \$61,256.00; and

WHEREAS, Florida Bullet Inc. is the only distributor in the State of Florida authorized to provide these products to law enforcement agencies in Florida; and

WHEREAS, Section 2-689 of the Procurement Code, entitled “Sole Source Procurement” authorizes an award without competitive bids when there is only one source available to fulfill the needs of the city; and

WHEREAS, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation and authorizes the City Manager to authorize the Police Department to purchase ammunition from Florida Bullet Inc. in an estimated amount of \$61,256.00, pursuant to Section 2-689 of the City’s Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


