RESOLUTION NO. 2020-101

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION TO AUTHORIZE THE PURCHASE OF CONTROL STATION EQUIPMENT WITHIN THE P25 RADIO SYSTEM FOR THE POLICE DEPARTMENT FROM COMMUNICATIONS INTERNATIONAL AS A “SOLE SOURCE PROCUREMENT,” PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, the P25 Radio System, which oversees all City radio equipment, requires control station radios with remote controllers to be purchased and installed throughout the new Police and Fire Headquarters building; and

WHEREAS, due to the desire to isolate potential lightning strikes from the rest of the building, these remote controllers will be connected via fiber optic cable; and

WHEREAS, the failure to utilize a L3Harris authorized service provider could result in equipment not fitting in the radio equipment room and being subjected to lightning strikes, causing a possible disruption to the City’s P25 radio network; and

WHEREAS, Communications International has the necessary specialized training and proprietary certifications required to provide this control station equipment; and

WHEREAS, the Police Department has selected Communications International based on its status as an authorized L3Harris partner, provider and seller of this proprietary equipment; and

WHEREAS, the cost for the purchase of this equipment totals \$846,644; and

WHEREAS, Section 2-689 of the Procurement Code, entitled “Sole Source Procurement” authorizes an award without competitive bids when there is only one source available to fulfill the needs of the City; and

WHEREAS, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption

hereof.

SECTION 2. That the City Commission accepts the recommendation and authorizes the City Manager to purchase control station equipment within the P25 Radio System from Communications International in the amount of \$846,644, pursuant to Section 2-689 of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


