## **RESOLUTION NO. 2025-02**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA, DIRECTING THE CITY MANAGER TO WORK WITH THE MIAMI-DADE COUNTY TAX COLLECTOR TO IDENTIFY POTENTIAL LOCATIONS WITHIN THE CITY FOR A FACILITY; PROVIDING FOR FLEXIBILITY IN LOCATION SELECTION AND CONSIDERATION OF PUBLIC NEEDS; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** the City of Coral Gables (the "City") owns various properties within its jurisdiction that could potentially accommodate public facilities; and

**WHEREAS,** the Miami-Dade County Tax Collector (the "Tax Collector") has expressed interest in establishing a facility within the City to better serve the needs of the public; and

**WHEREAS,** the City Commission finds that working collaboratively with the Tax Collector to identify suitable locations across the City would benefit both the City and the Tax Collector while enhancing services to the public;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The City Commission hereby directs the City Manager to engage with the Tax Collector to identify and evaluate potential locations within the City that may be suitable for a Tax Collector-operated facility, with consideration given to accessibility, public needs, and logistical feasibility.

**SECTION 3.** The City Commission reserves the right to review and approve any specific site recommendation and associated terms before proceeding with further negotiations or commitments.

**SECTION 4.** This Resolution shall become effective upon the date of its passage and adoption herein.
