RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE SANITARY SEWER SUBMERSIBLE ELECTRICAL CONTROL PANEL INSTALLATION TO CORELAND CONSTRUCTION CORP., THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE TOTAL ESTIMATED AMOUNT OF \$829,898.94, BUT NOT TO EXCEED AVAILABLE BUDGET PURSUANT TO INVITATION TO BIDS (IFB) 2026-005 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on February 27, 2026, the Procurement Division of Finance formally advertised, issued, and distributed Invitation for Bid (IFB) 2026-005 Sanitary Sewer Electrical Control Panel Installation; and

WHEREAS, one hundred thirty-seven (137) prospective bidders were notified through INFOR, the City's web-based e-procurement system; and

WHEREAS, on April 7, 2026, two (2) firms submitted bids in response to the IFB: C&I Construction and Design, Inc., and Coreland Construction Corp; and

WHEREAS, the Procurement Division finalized its' due diligence process and confirmed that Coreland Construction Corp., is both responsive to the requirements of the IFB and a responsible bidder; and

WHEREAS, the Public Works Department concurs with the Chief Procurement Officer's recommendation to award the Sanitary Sewer Submersible Electrical Control Panel Installation to Coreland Construction Corp; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer authorizing the City Manager to award the Sanitary Sewer Submersible Control Panel Installation to Coreland Construction Corp., the lowest responsive and responsible bidder in the estimated total amount of \$829,898.94 but not to exceed the available budget, pursuant to Invitation for Bids (IFB) 2026-005 and Section 2-763 of the procurement code entitled "contract award".

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
