Commissioner Lago: We are looking at another option and the City Manager met with the owner yesterday, they had a very good meeting. Again, it's going to be a long process, but I think what makes sense is what you stated. Again, we have a bird in the hand, so let's move forward,

Commissioner Mena: So, I think at this time what I'd like to just do is authorize Fred to again proceed with coming up with an actual plan of what he could do there, maybe put out a request to get some bids from people of what they could do and for what cost. There was some discussion at the meeting about some of the cost in other municipalities, which was rather exorbitant; and so, we want to see what we can do for a reasonable amount of money and for you to come back and report to us.

Mayor Valdes-Fauli: And that's at a local park.

Commissioner Mena: Nat Winiker Park.

City Manager Swanson-Rivenbark: Nat Winiker Park.

City Manager Swanson-Rivenbark: Nat Winiker Park does have some money earmarked for it, about....

Mr. Couceyro: \$350,000.

City Manager Swanson-Rivenbark: \$350,000.
