A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE BID OF SOLUTION CONSTRUCTION, INC., 7955 N. W. 12<sup>TH</sup> STREET, #425, MIAMI, FLORIDA 33126, THE LOWEST AND MOST RESPONSIVE BID, IN AN AMOUNT NOT TO EXCEED \$704,000.00 FOR THE CONSTRUCTION OF THE ROUNDABOUT AT CORAL WAY AND SEGOVIA STREET IN THE CITY OF CORAL GABLES.

**WHEREAS**, pursuant to the provisions of its Charter, the City advertised for bids for the construction of Roundabout at Coral Way and Segovia Street, Coral Gables, Florida. The following bids were opened on June 10, 2008:

**WHEREAS**, bid of Solution Construction, Inc., for the construction of the Roundabout at Coral Way and Segovia Street, Coral Gables, Florida, having been determined to be the lowest and most responsive, and having been recommended by the Public Works Department and the Miami-Dade County Department of Community Small Business (CSBE), said bid shall and it is hereby accepted in a sum not to exceed \$704,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1:** The recitals and findings contained in the preamble of this Resolution are adopted by reference and incorporated as if fully set forth in this Section.

**SECTION 2:** That the bid of Solution Construction, Inc., for the Construction of Roundabout at Coral Way and Segovia Street, of Coral Gables, Florida, having been determined to be the lowest bidder and best bid received, and having been recommended by the Public Works Department, said bid shall and it is hereby accepted in a sum not to exceed \$704,000.00.

**SECTION 3:** That the Finance Director is hereby directed to charge this project to the Impact Fee Funds, Account

**SECTION 4:** That this Resolution shall become effective upon the date of its adoption herein.
