A RESOLUTION OF THE CITY COMMISSION SETTING A TENTATIVE MILLAGE RATE OF 5.559 MILLS FOR THE FISCAL YEAR 2025-2026 ANNUAL OPERATING BUDGET TO BE SUBMITTED AS PRELIMINARY DISCLOSURE TO THE MIAMI-DADE COUNTY PROPERTY APPRAISER.

- **WHEREAS**, Florida Statutes, Chapter 200 establishes August 4th as the annual certification date for municipalities to set a tentative operating millage rate; and
- **WHEREAS**, in compliance with Article V of the City Charter, the City Manager prepared the Fiscal Year 2025-2026 Budget Estimate for submission to the City Commission on July 1, 2025; and
- **WHEREAS**, the City Manager provided a presentation on the Fiscal Year 2025-2026 Budget Estimate to the City Commission at a Budget Workshop held on Wednesday, July 2, 2025, at 9:00 AM; and
- **WHEREAS**, in the Fiscal Year 2025-2026 Budget Estimate, the City Manager recommended a Tentative Operating Millage rate of 5.559 mills;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.
- **SECTION 2.** That a Millage Rate of 5.559 mills is hereby passed and adopted as the Tentative Operating Millage for the Fiscal Year commencing October 1, 2025, and ending September 30, 2026.
- **SECTION 3**. That as required by Florida Statutes, Chapter 200, the Finance Director is hereby directed to file the tentative operating millage with the Miami-Dade Property Appraiser by August 4, 2025.
- **SECTION 4.** That this Resolution shall become effective immediately upon the date of its passage and adoption herein.
