**RESOLUTION NO. 2025-324**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE AND EXECUTION OF GRANT FUNDS IN THE AMOUNT OF \$7,970.00 ALLOCATED TO THE CORAL GABLES POLICE DEPARTMENT FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2024-2025 ANNUAL BUDGET TO RECOGNIZE THE \$7,970.00 GRANT FUNDS AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE GRANT EXPENDITURES.

**WHEREAS**, the Coral Gables Police Department is the established local law enforcement agency for the provision of law enforcement services within the jurisdictional boundaries of the City of Coral Gables; and

**WHEREAS**, the Coral Gables Police Department submitted an application to the State of Florida Department of Law Enforcement under the Edward Byrne Memorial Justice Assistance Grant Program; and

**WHEREAS**, the Coral Gables Police Department proposed the grant amount of \$7,970.00 be used to purchase equipment that will enhance community policing and engagement; and

**WHEREAS**, the State of Florida Department of Law Enforcement notified the Coral Gables Police Department that its grant application was successfully reviewed and approved via Award Number C-6N163 on June 6, 2025; and

**WHEREAS**, the Coral Gables Chief of Police requests acceptance of the grant and execution of the grant funds in the amount of \$7,970.00; and

**WHEREAS**, an amendment to the Fiscal Year 2024-2025 Annual Budget is required to recognize the \$7,970.00 grant as revenue and to appropriate such funds to cover the grant expenditures;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission hereby authorizes the acceptance and execution of grant funds in the amount of \$7,970.00 allocated to the Coral Gables Police Department from the Edward Byrne Memorial Justice Assistance Grant Program.

**SECTION 3.** That the City Commission hereby authorizes an amendment to the Fiscal Year 2024-2025 Annual Budget to recognize the \$7,970.00 grant funds as revenue and to appropriate such funds to cover the cost of the grant expenditures.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
