The state building code logether with all local amendments thereto is hereby adopted by reference, Penatties for violation of the state building code shall be as established in section 1-7.
Florida Building Code 105-[10]05 I. Required
Any owner or owner's authorized agent who retends to construct, entange, after, repair, move, demoish or change the occupancy of a building or structure, or to erect, install, enlarge, after, repair, remove, convert or replace any impact-resistant coverings, electrical, gas, mechanical or plumbing system, the installation of which is regulated by this code, or to cause any such work to be performed, shall, first make application to the building official and obtain the required permit.

Section 14-202 6. Correng permit.

No person shall commence or cause to be commenced any miscellaneous work, which does not otherwise requise a building permit, which affects the aesthebics, appearance, or architectural design of any structure, side or site improvements until an application for a zoning permit therefore has been previously filed with the flavelopment Services Department. No such macellaneous work which affects the aesthebics, appearance, or architectural design of any structure, side or side improvements shall commence until a permit has been issued by the City in every case where the coal of such proposed work exceeds five hundred (SOSO) dollars in above and materials. All work done under and pursuant to any zoning permit shall conform to the approved plans and/or specifications.

If this notice pertains to failure to maintain a historic structure, please be advised that:

- You may be subject to substantial fines that may not be mitigated.
- You may also be required to repair or restore the historic structure.
- If the historic structure is allowed to deteriorate to the point where it must be demolished:
 - the City Code requires that you replace the structure with a similar historically-appropriate structure; and
 - the property will no longer qualify for an historic preservation tax exemption.
