RESOLUTION NO. 2025-66

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER TO REQUEST ADDITIONAL SPENDING AUTHORITY IN THE ESTIMATED AMOUNT OF \$150,000, OR NOT TO EXCEED AVAILABLE BUDGET, FOR A CONTRACT AWARDED TO VERCETTI ENTERPRISES CONTRACT NO. IFB 2022-020 FOR THE VENETIAN POOL CONCESSION AREA RENOVATIONS PROJECT, PURSUANT TO SECTION 2-764 OF THE PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS".

WHEREAS, November 10, 2022, Vercetti Enterprises was awarded the contract for the restoration of the Venetian Pool Concession area through a competitive solicitation process IFB 2022-020 for the value of \$482,269; and

WHEREAS, during the course of completing the project it was discovered that additional services for structural enhancements were necessary and there were conflicts with plumbing, electrical, and mechanical; and

WHEREAS, the additional spending authority being requested will address the project changes identified and future unforeseen conditions, allowing the timely completion of this project;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.






