RESOLUTION NO. 2023-323

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE OCCUPATIONAL HEALTH & MEDICAL SERVICES CONTRACT RFP 2023-022 TO RICHARD L. DOLSEY PHC, INC. DBA PHYSICIANS HEALTH CENTER, THE HIGHEST RANKED RESPONSIVE-RESPONSIBLE PROPOSER, PURSUANT TO SECTION 2-763 OF THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on August 14, 2023, the Procurement Division of Finance formally advertised, issued, and distributed Drug/Alcohol & Physical Examination Services Project, RFP 2023-022. Twenty (20) prospective proposers were notified of the RFP package from INFOR; and

WHEREAS, on September 11, 2023, three (3) prospective firms submitted proposals in response to the RFP 2023-022 Drug/Alcohol & Physical Examination Services: Moya-Prida MD, Inc., Occupational Health Centers of the Southwest, P.A., Inc., and Richard L. Dolsey PHC, Inc. dba Physicians Health Center; and

WHEREAS, the responses were reviewed by the Procurement Division in order to determine responsiveness to the requirements of the RFP; and

WHEREAS, on October 6, 2023, the Evaluation Committee convened to evaluate the three (3) responsive and responsible proposals and ranked the firms in the following order of preference: Richard L. Dolsey PHC, Inc. dba Physicians Health Center (top-ranked), Occupational Health Centers of the Southwest, P.A., Inc. (second ranked), and Moya-Prida MD, Inc., (third ranked); and

WHEREAS, the Evaluation Committee further recommended that should negotiations fail with Richard L. Dolsey PHC, Inc. dba Physicians Health Center, that negotiations commence with the next highest ranked firm; and

WHEREAS, the Chief Procurement Officer recommends accepting the Evaluation Committee's recommendation to award and negotiate with Richard L. Dolsey PHC, Inc. dba Physicians Health Center, for RFP 2023-022 Drug/Alcohol & Physical Examination Services; and

WHEREAS, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to award the Drug/Alcohol & Physical Examination Services RFP 2023-022 to Richard L. Dolsey PHC, Inc. dba Physicians Health Center, the highest ranked responsive-responsible proposer, pursuant to Section 2-763 of the Procurement Code entitled “Contract Award”, further authorizing the City Manager to negotiate and execute a Professional Agreement for an initial period of three (3) years with option to renew for two (2) additional one (1) year periods, exercisable at the option of the City Manager; should negotiations fail with the highest ranked responsive-responsible proposer, negotiations shall commence with the next ranked firm.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
