RESOLUTION NO. 2020-178

A RESOLUTION OF THE CITY COMMISSION REAFFIRMING RESOLUTION 2019-323 AND URGING THE MIAMI-DADE BOARD OF COUNTY COMMISSIONERS TO COMPLETE THE OLD CUTLER TRAIL BICYCLE PATH ALONG OLD CUTLER ROAD.

WHEREAS, the Old Cutler Trail bicycle path currently passes through the gated residential neighborhood of Snapper Creek Lakes by way of Snapper Creek Road, circumventing a portion of Old Cutler Road that provides a more direct route between the intersection of S.W. 57th Avenue and Old Cutler Road and the intersection of Old Cutler Road and Snapper Creek Road; and

WHEREAS, the City Commission believes completing the Old Cutler Trail along Old Cutler Road would improve the trail-users experience, safety, and wayfinding rather than directing pedestrian and bicycle traffic through a residential neighborhood; and

WHEREAS, completion of the trail along Old Cutler Road would ensure clear and consistent signage and use of the trail and would provide some relief for the residents of Snapper Creek Road, which is the path trail users currently take; and

WHEREAS, dating back to 2004 and as recently as October 2019, via Resolution 2019-323, the City Commission urged Miami-Dade County to complete the trail but that has not yet occurred; and

WHEREAS, the City of Coral Gables urges Miami-Dade County to complete the Old Cutler Trail by connecting the southern and northern parts of the trail along Old Cutler Road and redirecting the Old Cutler Trail to avoid Snapper Creek Road;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission hereby reaffirms Resolution 2019-323 and newly urges Miami-Dade County to complete the Old Cutler Trail bicycle path and redirect the Old Cutler Trail along Old Cutler Road and away from Snapper Creek Road.

SECTION 3. That the City Commission directs the City Clerk to send a certified copy of this Resolution to the Miami-Dade County Commission.
