RESOLUTION NO. 2025-101

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE RETROACTIVE ACCEPTANCE OF AMENDMENT NO.1 TO GRANT AGREEMENT NO. A23005 WITH THE FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM (FRDAP), REVISING THE SCOPE OF WORK FOR THE BLUE ROAD NEIGHBORHOOD PROJECT.

WHEREAS, in October 2022, the City of Coral Gables entered into a grant agreement with the Florida Department of Environmental Protection under the Florida Recreation Development Assistance Program (FRDAP) to fund the construction of a newly designed Blue Road Neighborhood Park; and

WHEREAS, the original FRDAP grant scope included the construction of an observation/fishing pier, a walking trail, a play structure and surface, picnic facilities, benches, landscaping, lighting, fencing, waste receptacles, park plaque, drinking fountain and mister spray; and

WHEREAS, Amendment No. 1 to FRDAP Grant Agreement No. A23005 removes the construction of the observation deck/fishing pier and reallocates the funds originally designated for the observation deck/ fishing pier towards the play structure and surface;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission hereby authorizes the retroactive acceptance of Amendment No. 1 to FRDAP Grant Agreement No. A23005, which modifies the grant scope by removing the observation deck/fishing pier and reallocating those funds to the play structure and surface.

SECTION 3. That the City Manager is authorized to take all necessary actions to implement the terms of the amended agreement.

SECTION 4. That this Resolution shall become effective upon its passage and adoption herein.


