### City of Coral Gables CITY COMMISSION MEETING July 7, 2009

#### ITEM TITLE:

**Ordinance on First Reading.** An Ordinance of the City Commission of Coral Gables granting site plan approval for a proposed one story, less than 1,000 square feet “Plant Conservation Building”, located centrally within the Montgomery Foundation Property, and legally described as a portion of the Robert H. Montgomery Section (11901 Old Cutler Road), Coral Gables, Florida; providing for a repealer provision, a savings clause, and a severability clause, and providing for an effective date.

#### RECOMMENDATION OF THE CITY MANAGER:

Approval.

#### PLANNING DEPARTMENT RECOMMENDATION:

Recommend approval of the proposed site plan for the new “Plant Conservation Building”, located centrally within the Montgomery Foundation Property.

#### PLANNING AND ZONING BOARD RECOMMENDATION:

The Planning and Zoning Board at their 06.03.09 meeting unanimously recommended approval of the proposed site plan (vote: 5-0).

#### BRIEF HISTORY:

The Montgomery Botanical Center is an approximately 120 acre tropical plant research institution located in the south end of the City at the intersection of Old Cutler Road and Red Road. The Center is proposing to construct an office / work space for visiting scientists and academics that would be referred to as the “Plant Conservation Building”. One full time employee would work in the plant conservation building and up to 3 or 4 part time visiting professionals could use the facility for limited periods of time.

The proposed building is located centrally on the property, and would be part of the Center’s existing guest house and studio complex. The building is relatively small, consisting of a one story (15'-4") structure containing a total of 957 sq. ft. As a tropical plant research institution, the property is heavily landscaped and since the Plant Conservation Building is centrally located, it cannot be seen from either Old Cutler Road or Red Road.

Staff’s report and background information is provided as Exhibit B. The Planning and Zoning Board’s 06.03.09 meeting minutes are provided as Exhibit C. A summary of public comments submitted to the City is provided with Exhibit B.
