**ITEM TITLE:**

**Ordinance on Second Reading. Zoning Code Text Amendment.** An Ordinance of the City Commission of Coral Gables, Florida providing for a text amendment to the City of Coral Gables Official Zoning Code by amending Article 4, "Zoning Districts," Division 3, "Nonresidential Districts," Section 4-301, "Commercial Limited District" requiring conditional use review for medical-related uses located within a Commercial Limited zoning district; providing for repealer provision, severability clause, codification, and providing for an effective date.

**PLANNING AND ZONING BOARD RECOMMENDATION:**

The Planning and Zoning Board at their 07.12.17 meeting recommended approval (vote: 7-0).

**BRIEF HISTORY:**

City Staff is proposing a Zoning Code text amendment that will require all medical-related uses within a Commercial Limited zoning district to be reviewed via the conditional use approval process.

The proposed amendment will make all medical-related uses on property zoned Commercial Limited District a conditional use regardless of size or location. Conditional use review is necessary due to impacts on traffic and parking near single-family residences. Typically properties zoned Commercial Limited District are located adjacent to Single-Family Residential Districts. If approved all future applications for a medical clinic, medical laboratory, diagnostic and imaging center, and other medical-related uses will be required to be reviewed by the Planning and Zoning Board and receive approval by the City Commission.

At their 07.12.17 meeting, the Planning and Zoning Board recommended approval of the proposed Zoning Code text amendment (vote: 7-0). The proposed amendment is provided in the draft Ordinance in ~~strikethrough~~/underline format attached as Exhibit A.
