1 Remove existing sloped roof to wood do	eck. \$39,995.00

- 2 Supply & Install 1 layer of ASTM D 226 #30 felt tin capped to roof deck. 3/4 & 1 1/4 ring shank nails.
- 3 Supply & Install new 3X3 (Galvanized) eave drip metal to all eave lines and rakes.
- 4 Supply & Install new 16 inch valley metal to all valleys.
- 5 Supply & Install new lead stack flashings over plumbing stacks.
- 6 Supply & Install new 26 gauge galvanized roof vents. Prime all metal.
- 7 Supply & Install polyglass TU Plus mid ply (#90) to roof deck to create water tight seal.
- 8 Supply & Install Flat Tile 13" to entire sloped roof, set in poly foam adhesive. (Owner chooses color)
- 9 Supply & Install galv 26 GA 5X7 w/ stucco stop 26GA 5" w/lip to all necessary areas on the roof.
- 10 Uplift test done by a private company in order for final inspection to be approved is included.
- 11 Supply & Install up to 100 linear feet of fascia at no extra cost if necessary.
- 12 Supply & Install up to 200 sqft of Tonque & Groove and or Plywood at no extra cost if necessary.
- 13 Twelve year workmanship warranty included for work mentioned above on this proposal.

## WOODWORK & DECK RE-NAILING - Standard Lumber

In the event woodwork damage is encountered, this proposal includes 200' of sheathing or 6 sheets of plywood included at no cost. Additional woodwork pricing is as follows; Plywood - \$105.00 per sheet; Tongue & groove wood \$8.75 per linear foot; Fir strips - \$3.00 per linear foot; Fascia -\$9.75 per linear foot and rafter tails replaced at \$4.00 per foot; In the event stucco is needed to be applied to a flashing we charge \$4.00 per foot 12" wide. Please be aware if you have an open ceiling - due to the nail pattern required by the current code, the wood decking may crack, split or damage at the time of installation of #30. In the event the wood decking gets damage, please contact our office immediately so we can replace the damage wood. If any ac lines get punchured while renailing wood it will not be Atlas Roofing responsibility. The warranty can be transferrable for 20% of the contract price. Atlas Roofing Inc will not be responsible for any existing rain gutters or downspouts to be damaged in the process of tearing off or re-roofing the property.

Proposal Includes - Permits, Inspections, debris removal & Liability Insurance. Homeowner is responsible for having Solar Panels and/or Cable Dish removed/replaced.

Exclusions: As per new hurricane mitigation and retrofitting for structures undergoing alteration or re-roofs, new procedures have been in effect as
per October 1st, 2007. The repairs for the structure (Roof to Wall Connection) are not part of this proposal. Cost of this work may be up to 20% of
