Mayor Lago: I have one item. I'm asking for support on a resolution, like I mentioned before, to assemble a body of seven engaged citizens to serve on a temporary board for the limited purpose of facilitating the Mayor's Strategic Priorities Plan and providing periodic...to the City Commission.

City Attorney Ramos: Ms. Levi-Garcia, do you have anything to add on the resolution for the Mayor's Council?

Assistant City Attorney Levi-Garcia: No.

Commissioner Anderson: You have support.

Commissioner Menendez: Absolutely.

Mayor Lago: Motion?

Vice Mayor Mena: Motion.

Mayor Lago: Second.

Commissioner Anderson: Second.

Mayor Lago: Can we get a vote?

Commissioner Menendez: Yes

Mayor Lago: By the way, this is temporary.

Vice Mayor Mena: Quick point. I'm going to say it now because I think it's the opportune time to say it. I think this evening meeting is a service to residents from 4 to 8 and I think for the last three or four hours, frankly, has been a disservice because there is nobody watching. We're not, I'm not on my A-game at one in the morning, and so, I think we need to have a conversation about it, not necessarily now. One tweak I would suggest is, one of the things that I had originally suggested was just doing every other meeting and that morphed into yes, but when there is one meeting a month, let's do it in the evening. The problem with that is that my understanding is that we have how many morning meetings the rest of the year?

City Attorney Ramos: I think two, because August is one meeting, November is one meeting, December is one meeting.

Vice Mayor Mena: And it's compounded by the fact that because we had to defer so many items today, to another once-a-month meeting in August that's also going to be a long agenda.

Mayor Lago: But we hit it out of the park today.

Vice Mayor Mena: I'm just saying, I think we've got to think about this, because there is nobody that can persuade me that we have greater participation for the last three hours.

Commissioner Fors: Two things, for the record, somebody did tell me yesterday, what a shame that you guys are having these meetings in the evening, because people can't come. So, there is always two sides of the story. Secondly, I was checking on Zoom, I wasn't taking real data, but I believe there was less people on Zoom today than there was during the day.

City Clerk Urquia: At the start of the meeting, we had about 80 participants, right now we have 19, half is staff.

Mayor Lago: And the other half is like my wife asleep at the keyboard.

City Clerk Urquia: They are probably asleep on the phone.

Commissioner Menendez: And by the way, I don't know what time it was, I asked Billy at 9:43 p.m. we had 43 people on Zoom.

Mayor Lago: Yes, that's my whole family - my mom, my dad, everybody.

Commissioner Menendez: They are just checking in on you.

Mayor Lago: Cheering.

Commissioner Menendez: I have a suggestion with regards to that, and I agree, we need to tweak, we need to adjust. City of Miami when it has the evening meetings, its strictly Planning and Zoning, their P&Z meetings. If we can narrow the focus of the evening meetings so that, of course, if we don't have many P&Z then we can add other items, but if we can stay focused on a range of types of matters, we can get business done, we can get community involved, we can get things moving and we are not here till the clock stops.

Commissioner Anderson: You don't know what time...

City Attorney Ramos: If somebody wants to sponsor something for next time. Alternatively, is this, wait, hold on, hold on - is this the meeting after the resolution was adopted Billy?

City Clerk Urquia: Yes.

City Attorney Ramos: Okay. So, somebody can move to reconsider now, we could take that vote and then we can defer...

Commissioner Fors: I'll move to reconsider.

Vice Mayor Mena: I'll second.

Mayor Lago: I like the meetings, but we've just got to tweak it. For example, Protocols should not be in evening meetings, we can cancel a lot of things.

Commissioner Anderson: I think we can split the baby.

Mayor Lago: Yes.

Vice Mayor Mena: We can just do every other meeting.

Commissioner Anderson: I tried.

Vice Mayor Mena: It morphed into but, when there is one meeting a month, its in the evening, which again, compounds the problem, because the August meeting was a morning meeting, it would be less problematic that we just deferred ten items.

City Attorney Ramos: So, if we have a motion to reconsider the process, you all can

give me some direction and we can bring you back a resolution with some tweaks in August.

Mayor Lago: Okay, which is fine.

Commissioner Menendez: Those types of things. And the sooner we can start tweaking and adjusting the better for everybody.
