RESOLUTION NO. 2024-55

A RESOLUTION OF THE CITY COMMISSION RENAMING THE CITY OWNED PROPERTY CURRENTLY NAMED TIZIANO PARK LOCATED AT 7700 OLD CUTLER ROAD IN HONOR OF FALLEN PARARESCUEMEN, STAFF SERGEANT CARL PHILIPPE ENIS OF THE 308TH RESCUE SQUADRON WITH THE NAME "STAFF SERGEANT CARL ENIS VETERANS MEMORIAL PARK."

WHEREAS, the City Commission adopted a revised park naming policy via Resolution No. 2020-237; and

WHEREAS, the park naming policy allows the City Commission to nominate individuals for a naming honor and to waive any part of the parking naming process at their discretion; and

WHEREAS, the Mayor via discussion item 23-6878 recognized the accomplishments and ultimate sacrifice from Staff Sergeant Carl Enis and requested from staff to work with the Enis family to find an appropriate and fitting park to be named after him; and

WHEREAS, Staff Sergeant Carl Philippe Enis, was born March 31, 1986, in Miami Beach and grew up in Coral Gables and attended Gulliver Preparatory and received a bachelor's degree of Science in Environmental Studies and a Master of Business Administration from Florida State University; and

WHEREAS, Staff Sergeant Enis was a Pararescuemen (PJ's) in the United States Air Force. PJs are an elite team of Guardian Angel Airmen who serve as highly trained rescue specialists, providing life-saving trauma care and search and rescue; and

WHEREAS, on March 15, 2018, at 31 years of age, Staff Sergeant Enis was killed in a helicopter incident on the Syrian Iraq border, along with six other airmen; and

WHEREAS, the Community Recreation Department together with the input from the Enis family proposes the renaming the city owned property currently named Tiziano Park located at 7700 Old Cutler Road in honor of fallen Pararescuemen, Staff Sergeant Carl Philippe Enis; and

WHEREAS, this name designation is in accordance with the City's Park Naming Policy and has been reviewed and recommended with a unanimous vote by the Parks & Recreation Advisory Board;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and are hereby made a part of this Resolution upon adoption hereof.

SECTION 2. That the city owned property currently named Tiziano Park located at 7700 Old Cutler Road be renamed in honor of fallen Pararescuemen, Staff Sergeant Carl Philippe Enis of the 308th Rescue Squadron with the name “Staff Sergeant Carl Enis Veterans Memorial Park.”

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.




