1. APPLICATION REQUEST

The City of Coral Gables has initiated a request for a Zoning Code Text Amendment as follows:

An Ordinance of the City Commission of Coral Gables, Florida providing for a text amendment to the City of Coral Gables official Zoning Code amending Article 14, "Process", Section 14-200, "Procedures", Section 14-202, "General Development Review Procedures", Section 14-202.9, "Certificate of Use", to provide the City Manager or designee with authority to deny, suspend, or revoke a certificate of use under specific circumstances; providing for severability, repealer, codification, and an effective date.

2. APPLICATION SUMMARY

The City is proposing a Zoning Code text amendment to provide the City Manager or designee with the authority to deny, suspend, or revoke a Certificate of Use for good cause.

Currently, the City Manager already has the authority to revoke a Certificate of Use under specific circumstances in multiple sections of the Zoning Code, such as Section 3-611 for Covid-19 Recovery Temporary Use Permits and Section 3-312 for drive-throughs. The proposed text amendment will provide this authority to any Certificate of Use.

4. FINDINGS OF FACT

The request is a Text Amendment to Section 14-202.9. "Certificate of Use" in Article 14 "Process." The proposed changes are provided in Attachment A in strikethrough / underline format.

Zoning Code Section 14-212.5 provides review standards for Zoning Code text amendments:

Standard	Staff Evaluation			
a. Promotes the public health, safety, and welfare.	The proposed amendment provides the authority for the City Manager to revoke a Certificate of Use for good cause, which would be in the best interest of the public health, safety, and welfare.			
b. Does not permit uses the Comprehensive Plan prohibits in the area affected by the text amendment.	The proposed amendment does not permit any additional uses permitted in the Comprehensive Plan, but allows for better enforcement of the use.			
c. Does not allow densities or intensities in excess of the densities and intensities which are permitted by the future land use categories of the affected property.	The proposed text amendment does not affect the densities nor intensities any land uses.			
d. Will not cause a decline in the level of service for public infrastructure which is the subject of a concurrency requirement to a level of service which is less than the minimum requirements of the Comprehensive Plan.	The proposed text amendment will not affect the level of service for public infrastructure.			
e. Does not directly conflict with any objective or policy of the Comprehensive Plan.	The proposed amendment is to provide stricter enforcement of any non-residential use to the benefit of the community, which promotes many objectives of the Comprehensive Plan.			

Staff comments:

The proposed text amendment to Section 14-202.9 of the Zoning Code provides for the authority to revoke a Certificate of Use for good cause. This granted authority to further enforce non-residential uses fulfils the many goals, objectives, and policies of the Comprehensive Plan that protect the quality of life in Coral Gables. The standards identified in Section 14-212.5 for the proposed Zoning text amendment are **satisfied**.

5. STAFF RECOMMENDATION

Based upon the complete Findings of Fact contained within this report, staff recommends the following:

An Ordinance of the City Commission of Coral Gables, Florida providing for a text amendment to the City of Coral Gables official Zoning Code amending Article 14, "Process", Section 14-200, "Procedures", Section 14-202, "General Development Review Procedures", Section 14-202.9, "Certificate of Use", to provide the City Manager or designee with authority to deny, suspend, or revoke a certificate of use under specific circumstances; providing for severability, repealer, codification, and an effective date.

Staff recommends Approval.

AN ORDINANCE OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA PROVIDING FOR A TEXT AMENDMENT TO THE CITY OF CORAL GABLES OFFICIAL ZONING CODE AMENDING ARTICLE 14, "PROCESS", SECTION 14-200, "PROCEDURES", SECTION 14-202, "GENERAL DEVELOPMENT REVIEW PROCEDURES", SECTION 14-202.9, "CERTIFICATE OF USE", TO PROVIDE THE CITY MANAGER OR DESIGNEE WITH THE AUTHORITY TO DENY, SUSPEND, OR REVOKE A CERTIFICATE OF USE UNDER SPECIFIC CIRCUMSTANCES; PROVIDING FOR SEVERABILITY, REPEALER, CODIFICATION, AND AN EFFECTIVE DATE.

WHEREAS, the Coral Gables Zoning Code provides for a Certificate of Use process whereby the City has the authority to review and approve all uses except single family and multi-family uses; and

WHEREAS, this amendment grants the City Manager or designee the express authority to deny, suspend, or revoke a Certificate of Use for good cause; and

WHEREAS, the City Manager already has the authority to revoke a Certificate of Use under specific circumstances in multiple sections of the Zoning Code, such as Section 3-611 "Covid-19 Emergency Business Recovery Temporary Use Permit" and Section 3-312 "Drivethroughs, walk-up windows, and automated teller machines (ATM)"; and

WHEREAS, an applicant may appeal a denial, suspension, or revocation of a Certificate of Use pursuant to the appeals process outlined in this amendment; and

WHEREAS, the Planning and Zoning Board was presented with this text amendment to the Official Zoning Code, and after due consideration and discussion, recommended approval/denial (vote: –);

NOW THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption hereof.

SECTION 2. The Official Zoning Code of the City of Coral Gables is hereby amended as follows¹:

¹ Deletions are indicated by strikethrough. Insertions are indicated by <u>underline</u>.

- A. Except for single family and multi-family uses, no person shall commence any use of any property, nor shall an occupational license or building permit be issued until an application for a Certificate of Use therefore has been filed with and approved by the Development Services Department on a form provided by the Department.
- <u>B.</u> Any use of a property under and pursuant to any Certificate of Use shall conform to the Certificate of Use. Any use for which a Certificate of Use has been issued must commence within one hundred and eighty (180) days of the issuance of the Certificate of Use, and is valid for a period not to exceed one (1) year from the date of the issuance. All Certificates of Use shall be renewed by the applicant each year.
- C. The City Manager or designee may deny, suspend, or revoke a Certificate of Use for good cause, including but not limited to one of the following reasons:
 - 1. The applicant provided false or misleading information in the application or in the supplemental or additional statements of fact or studies required by the City.
 - 2. There is a failure to comply with the terms or conditions of the Certificate of Use.
 - 3. There is a violation of these regulations or of the Code of the City of Coral Gables, Florida.
 - 4. The premises is allowed to be utilized for illegal criminal activity or activity not permitted under the Zoning Code or City Code.
 - 5. The Business Tax Receipt ("BTR") for the Certificate of Use holder has been denied, suspended, or revoked.
- <u>D.</u> A denial, issuance, revocation, or suspension of a Certificate of Use may be appealed pursuant to Section 14-208 of the Zoning Code.
- E. There shall also be an alternative expedited appeal process whereby an appellant may choose to appeal a denial, issuance, revocation, or suspension of a Certificate of Use to a special magistrate. Such process shall require the appeal to be submitted in writing to the City Clerk within ten (10) business days of the denial, issuance, revocation, or suspension. The City Manager or designee shall have five (5) business days to respond in writing. A special magistrate appointed by the City will review the filings and render a written order within ten (10) business days of receipt of the appeal.

SECTION 3. All ordinances or parts of ordinances inconsistent or in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 4. If any section, part of section, paragraph, clause, phrase or word of this Ordinance is declared invalid, the remaining provisions of this Ordinance shall not be affected.

SECTION 5. It is the intention of the City Commission that the provisions of this Ordinance shall become and be made part of the "Zoning Code" of the City of Coral Gables, Florida; and that the sections of this Ordinance may be changed to "section", "article", or such other appropriate word or phrase in order to accomplish such intention.

PUBLIC NOTICE is hereby given that the City of Coral Gables, Florida, Local Planning Agency (LPA)/ Planning and Zoning Board (PZB) will conduct Public Hearing on the following:

- 1. An Ordinance of the City Commission granting approval of proposed amendments to the text of the City of Coral Gables Comprehensive Plan, pursuant to expedited state review procedures (S.163.3184, Florida Statutes) and Zoning Code Article 14, "Process," Section 14-213, "Comprehensive Plan Text and Map Amendments;" to provide that the maximum number of floors in the Comprehensive Plan shall not apply to any Planned Area Development (PAD) upon City Commission approval, and to allow an additional height bonus in return for limiting density for qualifying PADs within the Central Business District (CBD); providing for a severability clause, repealer provision, and providing for an effective date. (On 12 08 2021, PZB deferred this item to January's meeting.)
- 2. An Ordinance of the City Commission providing for text amendments to the City of Coral Gables Official Zoning Code, Article 2, "Zoning Districts" Section 2-500 "Planned Area Development," (pad) to provide that upon City Commission approval, the maximum number of stories in any PAD shall not apply; and to create A "Height Bonus to PAD Minimum Development Standards in the Central Business District (CBD)" providing additional height with a limit of density for qualifying properties upon City Commission approval; providing for severability clause, repealer provision, codification, and providing for an effective date. (On 12 08 2021, PZB deferred this item to January's meeting.)
- 3. An Ordinance of the City Commission of Coral Gables, Florida providing for a text amendment to the City of Coral Gables official Zoning Code amending Article 14, "Process", Section 14-200, "Procedures", Section 14-202, "General Development Review Procedures", Section 14-202. 9, "Certificate of Use", to provide the City Manager or designee with authority to deny, suspend, or revoke a certificate of use under specific circumstances; providing for severability, repealer, codification, and an effective date.

- 4. An Ordinance of the City Commission of Coral Gables, Florida, providing for text amendments to the City of Coral Gables Official Zoning Code, Article 5, "Architecture," Section 5-200, "Mediterranean Standards;" to limit the Mediterranean Bonus program to Coral Gables Mediterranean Architectural Style and expand the Board of Architects review process to include an optional conceptual review; providing for severability, repealer, codification, and for an effective date. (On 12 08 2021, PZB deferred this item to January's meeting.)
- 5. An Ordinance of the City Commission of Coral Gables, Florida providing for a text amendment to the City of Coral Gables Official Zoning Code by amending Article 14, "Process," Section 14-103.2, "Membership; Terms; Vacancies; Removal," to allow a certain percentage of the Board of Architects members to not be residents or have the principal place of business in the City of Coral Gables; providing for severability, repealer codification, and an effective date.
