Update regarding compliance with City regulations on placement of mailboxes by the U.S. Postal Service.

Mayor Cason: I-2 – mailboxes.

City Attorney Leen: I-2: Update regarding compliance with City regulations on placement of mailboxes by the U.S. Postal Service. I'm going to turn it over to the Deputy City Attorney to talk about a little bit with this, but this is another instance where the City is raising its Zoning Code and making sure that as a matter of committee, as a matter of respect from different governments that our Zoning Code be respected. So with that I'll turn it over to Ms. Ramos.

Ms. Ramos: Hi again. So our office conducted some research on whether mailboxes in a

townhouse complex can be placed in a self pre-standing structure with multiple mailboxes, rather

than on each door. Our Code is silent, our Zoning Code, I should specify is silent as to mailboxes

in particular. But what we did find was that the accessory use structure section of our Zoning

Code would be applicable to mailboxes in the way that they are being contemplated here. So a

freestanding structure with multiple mailboxes. 5-101(b) of our Zoning Code prohibits accessory

buildings and structures between the street and the main building, and subsection (c) also

prohibits accessory buildings from being located closer to the front or side of the lot or building

site. Therefore, our conclusion is that to have a self-standing structure with multiple mailboxes in

a townhouse complex would be in violation of our Zoning Code.

City Attorney Leen: And to provide some further context. The request came to us really from the

U.S. Postal Service. What they are saying is that they want for townhomes, townhouses this

centralized mailbox unit that's in between the townhouses and the street with a lot of different

mailboxes. Instead of having a mailbox for each unit, which is what our practice is and what our

Zoning Code requires, and we've responded that our Zoning Code doesn't allow that. They've

asked for an opinion and I'll turn it back over to Ms. Ramos, but the one thing I would ask is, its

one thing for the City Attorney to say that and under the Code I believe that we should follow

that, but its another thing for the Commission to say. So I'd ask that you also, assuming you like

the opinion, that you adopt it.

Ms. Ramos: And the opinion has been drafted and I believe circulated to all of you. It is our

conclusion that the mailboxes need to be placed at each door to comply with our Zoning Code,

and also you should know that there was a similar Code provision at Pompano Beach and it was

upheld by...

Mayor Cason: They are not going to respond by saying, well we are not going to deliver the mail

there, we don't think they are going to do that.

Ms. Ramos: I don't think that they can do that.

City Attorney Leen: I don't think they can do that, although obviously we'll have to look at that

if that comes up, but right now we just want to show them – what they asked for was just a

memo explaining why our law requires this, we think that they will respond positively. We are

not positive, but it would be helpful that the Commission say that, that's the way that we view

our law.
