**RESOLUTION NO. 2010-240**

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE CITY PUMP STATION 3 REHABILITATION PROJECT TO GOVERNOR CONSTRUCTION, INC. PURSUANT TO SECTION 2-828 ENTITLED "CONTRACT AWARD" OF THE PROCUREMENT CODE AND IFB 2010.09.02 IN THE AMOUNT OF \$764,000 (SEVEN HUNDRED SIXTY-FOUR THOUSAND DOLLARS); AMENDING THE 2010-2011 ANNUAL BUDGET TO INCREASE THE ESTIMATED REVENUES AND FURTHER AUTHORIZING AN APPROPRIATION OF FUNDS FOR THIS PROJECT.

**WHEREAS**, on September 2, 2010, the Procurement Division of Finance formally advertised the City Pump Station 3 Rehabilitation Project Invitation to Bid (IFB) 2010.09.02; and

**WHEREAS**, on September 16, 2010, a non-mandatory pre-bid conference was held followed by a site visit with fourteen (14) prospective bidders in attendance of the thirty-four (34) contractors and subcontractors who obtained bid documents from the Procurement Division of Finance; and

**WHEREAS**, on October 6, 2010, twelve (12) responsive bids were submitted by: ABC Construction, Inc., Metro Equipment Services, Inc., Gonzalez and Sons Equipment, Inc., Comtech Engineering, Inc., R&G Engineering, Inc., HA Contracting Corporation, Horizon Contractors, Inc., Intercounty Engineering, Inc., Wrangler Construction, Inc., RG Underground Engineering, Inc., Chaz Equipment Co., Inc., Governor Construction, Inc. with one (1) no bid from Florida Design Contractors, Inc.; and

**WHEREAS**, The lowest responsive responsible bid for the City Pump Station 3 Rehabilitation Project was submitted by Governor Construction, Inc. with their bid of \$764,000.00 (seven hundred sixty-four thousand dollars); and

**WHEREAS**, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

**WHEREAS**, the 2010-2011 Annual Budget is to be amended to include an increase in estimated revenues and an appropriation of funds in the amount of \$500,000.00 (five hundred thousand dollars) from the Florida Department of Environmental Protection (DEP) Agreement No. LP8910; and appropriate the amount of \$264,000.00 (two hundred sixty-four thousand dollars) from the Sanitary Sewer Fund are hereby authorized for the City Pump Station 3 Rehabilitation Project;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby accept the recommendation of the Chief Procurement Officer to award the contract to Governor Construction, Inc. pursuant to Section 2-828, entitled "*Contract Award*" of the Procurement Code and IFB 2010.09.02 in the amount of \$764,000.00 (seven hundred sixty-four thousand dollars).

**SECTION 3.** That the 2010-2011 Annual Budget is to be amended to include an increase in estimated revenues and an appropriation of funds in the amount of \$500,000.00 (five hundred thousand dollars) from the Florida Department of Environmental Protection (DEP) Agreement No. LP8910; and appropriate the amount of \$264,000.00 (two hundred sixty-four thousand dollars) from the Sanitary Sewer Fund are hereby authorized for the City Pump Station 3 Rehabilitation Project.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
