- A.-1. [25-1058](#) Presentation of a Certificate of Recognition to Dr. Josephine Johnson - Professor Emeritus of the University of Miami School of Communication.

The City Commission meeting began with special recognition honoring Dr. Josephine Johnson on the occasion of her 100th birthday, celebrated on January 25, 2025. Born in the same year as the incorporation of Coral Gables, Dr. Johnson holds the distinguished title of Chair Emeritus at the University of Miami and is credited as the founder of the School of Communications in 1985. She has been an active member of the Historic Preservation Association of Coral Gables and played a pivotal role in designating the Alcazar Historic District and preserving the Chica Lodge Cemetery, now known as the Pioneer Cemetery. Her accomplishments include authoring *SS Asteroid or Tell It to the Bees* in 2009, chronicling her restoration of a historic World War II vessel, and co-founding the Dearborn School at 311 Sevilla Avenue, contributing significantly to the educational fabric of the community. Commissioners praised her unwavering dedication to historic preservation and her enduring love for Coral Gables. Dr. Johnson expressed gratitude for the recognition and encouraged continued efforts to preserve the city's heritage, noting her hope for a commemorative plaque for the Dearborn School to honor its legacy.

The City Commission then turned its attention to maternal and infant health, proclaiming November 17, 2025, as World Prematurity Day in Coral Gables. This proclamation recognized the critical work of the March of Dimes in combating the maternal and infant health crisis through research, education, and advocacy. Sarah Bloom, Senior Manager of Donor Development for March of Dimes, highlighted Florida's troubling D-plus rating on the 2024 report card and the fact that more than one in ten babies in the state are born preterm. She emphasized the importance of continued collaboration and awareness to improve outcomes for mothers and babies. Commissioners expressed gratitude for the organization's efforts and reaffirmed the city's commitment to supporting this cause.
