An Ordinance of the City Commission of Coral Gables, Florida, pursuant to the authority granted by the Dade County Home Rule Amendment to the Florida Constitution, conflicting with, modifying, and nullifying the preemption of polystyrene regulations in Chapter 2016-01, Laws of Florida (to be encoded as Section 500.90 of the Florida Statutes), to the extent that such preemption is a local, special or general law applicable only to the City of Coral Gables in Miami-Dade County, and determining that the City's polystyrene regulations are not preempted and remain enforceable.

Mayor Cason: Let's move onto Item E-1, which is an Ordinance on Second Reading.

City Attorney Leen: Thank you Mr. Mayor. Item E-1 is an Ordinance on Second Reading. An Ordinance of the City Commission of Coral Gables, Florida, pursuant to the authority granted by the Dade County Home Rule Amendment to the Florida Constitution, conflicting with, modifying, and nullifying the preemption of polystyrene regulations in Chapter 2016-01, Laws

of Florida (to be encoded as Section 500.90 of the Florida Statutes), to the extent that such preemption is a local, special or general law applicable only to the City of Coral Gables in Miami-Dade County, and determining that the City's polystyrene regulations are not preempted and remain enforceable. Again, quality of life is directly correlated to open space, to good environment, and this is an example of us really blazing the trail in South Florida and I hope that other cities do not fall asleep in regards to this preemption law and truly walk with us down this path and hopefully making polystyrene a thing of the past.
