ORDINANCE NO. 2008 - 17

AN ORDINANCE REPEALING ORDINANCE NO. 2003-27 WHICH ALLOWED THE CITY COMMISSION TO EXEMPT CERTAIN ADVISORY BOARDS AND COMMITTEES FROM COMPLYING WITH THE REQUIREMENTS OF THE CITY CODE CHAPTER 2, "ADMINISTRATION", ARTICLE V, "CONFLICT OF INTEREST AND CODE OF ETHICS"; PROVIDING FOR SEVERABILITY, CODIFICATION AND REPEALING ALL ORDINANCES INCONSISTENT HEREWITH.

WHEREAS, the City Commission, pursuant to Ordinance No. 2003-27, exempted certain boards and committees with limited jurisdictional and advisory duties from complying with the requirements of the Conflict of Interest and Code Ethics Ordinances of the City and the County; and

WHEREAS, the County, with the passage of Ordinance 08-53 on May 8, 2008, deleted the provisions from the Miami-Dade County Code Sec. 2-11.39.2 which provided for exemption for certain boards and committees with such limited duties; and

WHEREAS, the City wishes to repeal its ordinance which amended the code to exempt such advisory boards and committees;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That Ordinance No. 2003-27 amending Ordinance No. 2003-5 and Chapter 2 of the "Code of the City of Coral Gables" entitled "Administration", Article V entitled "Conflict of Interest and Code of Ethics", is hereby repealed.

SECTION 3. That the City Clerk is directed to transmit a certified copy of this ordinance to the Miami-Dade County Commission on Ethics and Public Trust.

SECTION 4. That if any section, subsection or provision of this Ordinance is held invalid, the remainder shall not be affected by such invalidity.

SECTION 5. That all ordinances or parts of ordinances in conflict or inconsistent herewith are hereby repealed insofar as there is conflict or inconsistency.

SECTION 6. This Ordinance shall become effective thirty days from the date of its passage and adoption herein.
