RESOLUTION NO. 2025-407

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF GRANT AGREEMENT NO. DA-CG-25-307 FROM THE FLORIDA INLAND NAVIGATION DISTRICT IN THE AMOUNT OF \$56,500 FOR THE PURCHASE OF A SMALL MARINE PATROL VESSEL AND NIGHT VISION EQUIPMENT; AUTHORIZING AN AMENDMENT TO FISCAL YEAR 2025-2026 ANNUAL BUDGET TO RECOGNIZE THE GRANT FUNDS AS REVENUE AND APPROPRIATE SUCH FUNDS TOWARD THE COST OF THE PROJECT.

WHEREAS, on March 11th, 2025, the City Commission authorized the City Manager to apply for financial assistance from the Florida InLand Navigation District (the District), for the acquisition of a Small Marine Patrol Vessel and Night Vision Equipment; and

WHEREAS, the district agreed to provide said financial assistance for the acquisition of a small vessel and night vision equipment to patrol the intracoastal waterways of the City of Coral Gables and Biscayne Bay; and

WHEREAS the City awarded the competitive grant in the amount of \$56,500, with a \$56,500 match, resulting in a total project cost of \$113,000; and

WHEREAS, an amendment to the Fiscal Year 2025-2026 annual budget is required to recognize the grant funds in the amount of \$113,000 as revenue and to appropriate such funds to cover the cost of the grant expenditures;

NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. That the City Commission does hereby authorizes the City Manager to execute agreement no. DA-CG-25-307 with the Florida InLand Navigation District and any amendments thereafter.

SECTION 3. The City Commission does hereby authorize an amendment to the Fiscal Year 2025-2026 annual budget to recognize the grant funds as revenue and to appropriate such funds to cover the cost of the grant expenditures.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.

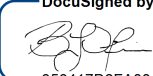
