& R PAVING, INC., PURSUANT TO INVITATION  
FOR BID (IFB) 2014.05.20, AND SECTION 2-828 OF  
THE           PROCUREMENT           CODE           ENTITLED  
"CONTRACT AWARD".

**WHEREAS**, on May 20, 2014, the Procurement Division of Finance formally advertised issued and distributed the Hammock Lake Subdivision Street Resurfacing Improvements IFB 2014.05.20; and

**WHEREAS**, on June 3, 2014, a non-mandatory pre-bid conference was held with three (3) prospective bidders in attendance of the eight (8) contractors who obtained the bid package from the Procurement Division of Finance; and

**WHEREAS**, on June 24, 2014, six (6) bids were submitted by H&R Paving, Inc., Metro Express, Inc., General Asphalt Company, Inc., JVA Engineering Contractor, Inc., H&J Asphalt, Inc., Rock Power Paving, Inc.; and

**WHEREAS**, the lowest responsive responsible bidder for this contract was determined to be H & R Paving, Inc., with a bid of \$426,085.16; and

**WHEREAS**, the Chief Procurement Officer pursuant to Section 2-828 of the Procurement Code entitled "Contract Award" and Invitation for Bid (IFB) 2014.05.20 recommends that H & R Paving, Inc., be awarded the Hammock Lake Subdivision Street Resurfacing Improvements; and

**WHEREAS**, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer to award the Hammock Lake Subdivision Street Resurfacing Improvements contract to H & R Paving, Inc., pursuant to Invitation For Bid (IFB) 2014.05.20, and Section 2-828 of the Procurement Code entitled "Contract Award", subject to final approval and execution of a contract by City staff.

**SECTION 3.** That this Resolution shall become effective upon the date of its adoption herein.
