## **RESOLUTION NO. 2021-28**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE AND EXECUTION OF GRANT FUNDS IN THE AMOUNT OF \$10,000 ALLOCATED TO THE CORAL GABLES POLICE DEPARTMENT FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2010-2021 ANNUAL BUDGET TO RECOGNIZE THE \$10,000 GRANT FUNDS AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE GRANT EXPENDITURES.

WHEREAS, the Coral Gables Police Department is the established local law enforcement agency for the provision of law enforcement services within the jurisdictional boundaries of the City of Coral Gables; and

WHEREAS, the Coral Gables Police Department submitted for consideration grant application 2021-JAGD-DADE-5-4R-011 to the State of Florida Department of Law Enforcement under the Edward Byrne Memorial Justice Assistance Grant Program; and

WHEREAS, the Coral Gables Police Department proposed the grant amount of \$10,000 be used to purchase K9 unit equipment that will enhance Police canine safety, and traffic enforcement equipment that will improve the safety of residents and visitors driving through the City of Coral Gables; and

WHEREAS, the State of Florida Department of Law Enforcement notified the Coral Gables Police Department that its grant application was successfully reviewed and approved on February 1, 2021; and

WHEREAS, the Coral Gables Chief of Police requests acceptance of the grant and execution of the grant funds in the amount of \$10,000; and

WHEREAS, an amendment to the Fiscal Year 2020-2021 Annual Budget is required to recognize the \$10,000 grant as revenue and to appropriate such funds to cover the grant expenditures;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1**. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission hereby authorizes the acceptance and execution of grant funds in the amount of \$10,000 allocated to the Coral Gables Police Department from the Edward Byrne Memorial Justice Assistance Grant Program.

**SEECTION 3.** That the City Commission hereby authorizes an amendment to the Fiscal Year 2020-2021 Annual Budget to recognize the \$10,000 grant funds as revenue and to appropriate such funds to cover the cost of the grant expenditures.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
