RESOLUTION NO. 2022-189

A RESOLUTION OF THE CITY COMMISSION
REJECTING ALL PROPOSALS FOR RFP NO. 2022-008
AND INSTRUCTING THE CHIEF PROCUREMENT
OFFICER TO REISSUE THE SOLICITATION,
PLACING GREATER EMPHASIS ON PRICE.

WHEREAS, on Wednesday, July 13, 2022, the City Manager provided his written recommendation to the City Commission for RFP No. 2022-008 “Citywide Landscape Maintenance”, adopting the evaluation committee’s recommendation; and

WHEREAS, at the City Commission Meeting on July 25, 2022, the City Commission reviewed and discussed the City Manager’s recommendation and there was consensus among the City Commission that price should play a more prominent role in the selection of a proposal for the citywide landscape maintenance contract award; and

WHEREAS, based on a finding that placing a larger value on pricing is in the best interest of the City, the City Commission decided to reject all proposals and direct the Chief Procurement Officer to reissue a new solicitation pursuant to Section 2-685(2)(c) of the Procurement Code that places a greater emphasis on price;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon its passage and adoption hereof.

SECTION 2. That the City Commission hereby rejects all proposals for RFP No. 2022-008, pursuant to Section 2-685(2)(c) of the Procurement Code and instructs the Chief Procurement Officer to reissue a new solicitation that places a greater emphasis on price.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


