WHEREAS, while City staff has always presented an overview of those changes and outlined them in the budget document, in order for the information related to employee and commission salaries to be more easily accessible to the public, the City Commission wishes to direct the City Manager to include a schedule(s) in each version of the budget presented to the City Commission that outlines the changes in salaries by department from the previous version of the budget presented to the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:
