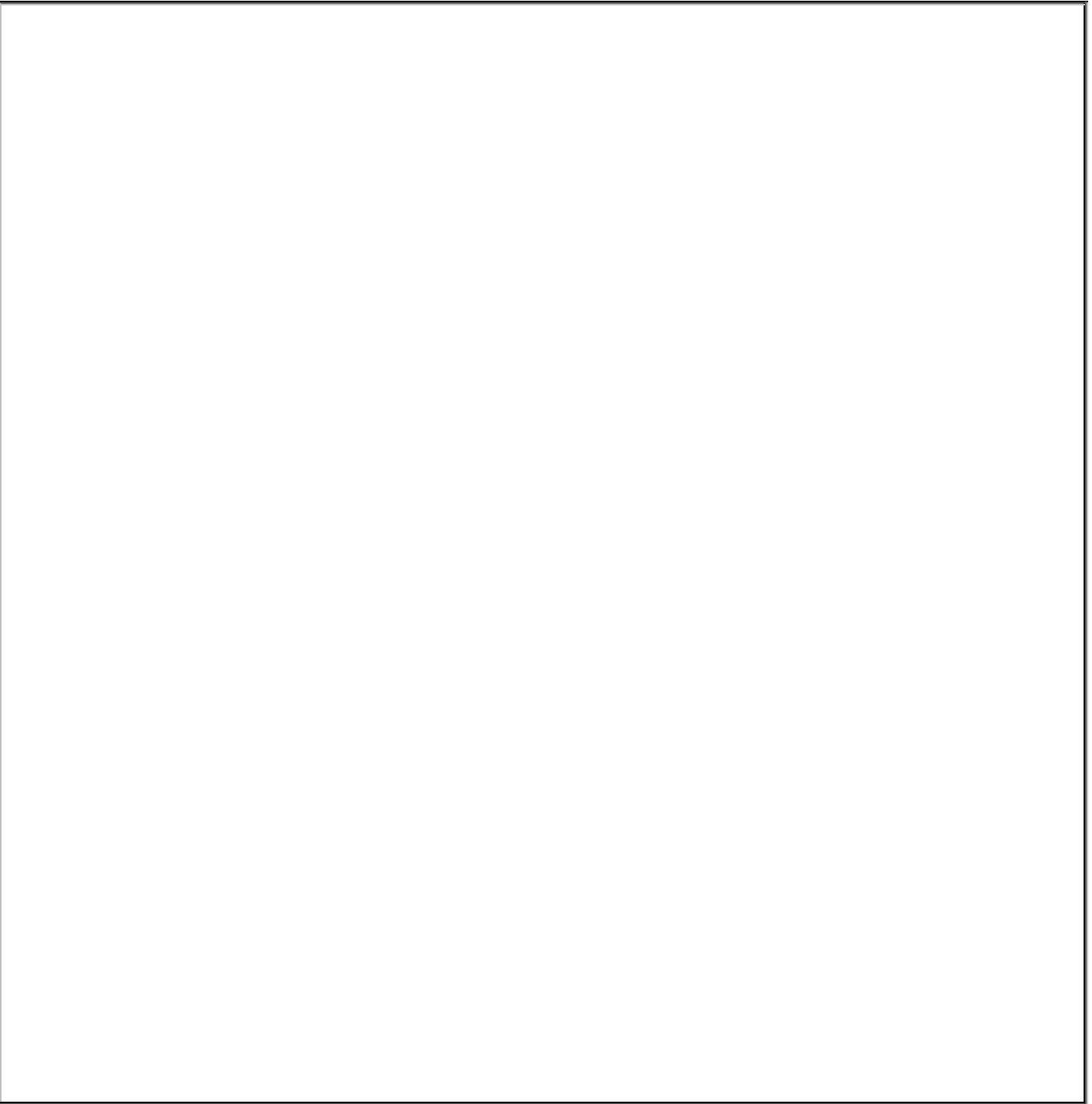
Alan E. Greenfield invoice dated October 20, 2008 for legal services from June 11, 2008 to October 20, 2008 in the amount of \$9,675.00.
