A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE KIWANIS CLUB OF LITTLE HAVANA TO CONDUCT THE “**CARNIVAL ON THE MILE**” EVENT ON MIRACLE MILE AND AUTHORIZING TO SELL ALCOHOLIC BEVERAGES FROM 12:00 P.M. TO MIDNIGHT ON SATURDAY, MARCH 7, 2020, AND FROM 12:00 P.M. TO 10:00 P.M. ON SUNDAY, MARCH 8, 2020 ON MIRACLE MILE FROM DOUGLAS TO LEJEUNE AS PART OF THE CARNAVAL ON THE MILE, SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

WHEREAS, this request has been reviewed by the City’s Special Events Committee;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the Kiwanis Club of Little Havana be approved to celebrate “**CARNIVAL ON THE MILE**” in Coral Gables. This request is to serve alcoholic beverages during the celebration and is subject to compliance with the laws of the State of Florida.

SECTION 2. “**CARNIVAL ON THE MILE**” will take place from 10:00 a.m. to midnight on Saturday, March 7, 2020, and from 10:00 a.m. to 10:00 p.m. on Sunday, March 8, 2020 at Miracle Mile - Douglas Road to LeJeune Road.

SECTION 3. The Kiwanis Club of Little Havana is approved to sell alcoholic beverages from 12 p.m. to midnight on Saturday, March 7, 2020 and from 12 p.m. to 10 p.m. on Sunday, March 8, 2020.

SECTION 4. The event is family oriented with music and an art festival.
