A RESOLUTION APPROVING THE CONCEPT FOR A WORK OF PUBLIC ART BY MICHAEL KALISH IN CONJUNCTION WITH THE SUNRISE SENIOR LIVING DEVELOPMENT PROJECT AT 1000 PONCE DE LEON BOULEVARD IN FULFILLMENT OF THE ART IN PUBLIC PLACES REQUIREMENT FOR PUBLIC ART IN PRIVATE DEVELOPMENT (UNANIMOUSLY RECOMMENDED BY THE ARTS ADVISORY PANEL APPROVAL/DENIAL VOTE: 5 TO 0, AND THE CULTURAL DEVELOPMENT BOARD APPROVAL/DENIAL VOTE: 7 TO 0).

WHEREAS, Sunrise Senior Living (the “Developer”) is constructing an assisted living and memory care center at 1000 Ponce de Leon Boulevard (the “Project”). The Developer has chosen the option of petitioning for a waiver of the Art in Public Places Fee requirement by commissioning and installing artwork within the project as specified in the Zoning Code, Article 3, Division 21; and

WHEREAS, the Project meets the requirement to contribute one percent (1.0%) of the aggregate project value to the Art Acquisition Fund pursuant to Article 3, Section 3-2103 Sub-section A2 of the Coral Gables Zoning Code; and

WHEREAS, Michael Kalish (the "Artist"), selected by the Developer, was approved as a qualified artist by the Arts Advisory Panel in accordance with the City of Coral Gables Art in Public Places: Funding, Goals, and Implementation Guidelines; and

WHEREAS, on July 22, 2020, a concept proposal of a public artwork by Michael Kalish was presented to the Arts Advisory Panel for review, which recommended acceptance of the concept to the Cultural Development Board; and

WHEREAS, on August 4, 2020, the concept proposal of the recommended public artwork by Michael Kalish was presented to the Cultural Development Board, which reviewed it and accepted the recommendation of the Arts Advisory Panel to recommend the Artists’ concept; and

WHEREAS, the proposed art piece is estimated to be \$430,000 (four hundred thirty thousand dollars) which is less than the required 1% of the Aggregate Project Value of \$517,126 (five hundred seventeen, one hundred twenty-six thousand dollars) (as shown on Exhibit A attached hereto); therefore, the Developer will pay any balance to the Art Acquisition Fund.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “Whereas” clauses are here hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby approve the Artist's concept and proposed preliminary budget for a work of public art by Michael Kalish in partial fulfillment of the Art in Public Places requirement, attached hereto as Exhibit A, provided that such work shall meet all other applicable criteria of the Zoning Code, and other applicable codes, statutes, laws, rules, and regulations; and pays any difference in the balance to the City for deposit into the Art in Public Places fund.

SECTION 3. That this resolution shall become effective upon the date of its passage and adoption herein.
