RESOLUTION NO. 2014-195

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND THE CURRENT THEATRE\DRAMA PROFESSIONAL SERVICES CONTRACT WITH MIAMI CHILDREN'S THEATRE, PURSUANT TO SECTION 2-829 OF THE PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS", UNTIL DECEMBER 31, 2014, AND THEREAFTER ON A MONTH-TO-MONTH BASIS UNTIL THE RFP PROCESS IS COMPLETED AND A NEW CONTRACT IS EXECUTED.

WHEREAS, on April 28, 2009, the City Commission approved a contract to run from May 28, 2009, to May 28, 2011, with the firm, Miami Children's Theatre, to provide Theatre/Drama Professional Services at the Coral Gables War Memorial Youth Center; and

WHEREAS, this contract also provided for three (3) one (1) year extensions with the last extension expiring on May 28, 2014; and

WHEREAS, in order to provide time for the Request for Proposal (RFP) process to be completed and for a new contract to be approved and to authorize an extension of the existing contract, it is recommended that the Theatre/Drama Professional Services Contract with Miami Children's Theatre, be extended until December 31, 2014, and

WHEREAS, the Theatre/Drama Professional Services Request for Proposal will be advertised during the month of October, 2014, with a recommendation being submitted to the City Commission for a new contract in November-December, 2014; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, the Theatre/Drama Professional Services Contract with Miami Children's Theatre, may be extended under Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications";

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accept the recommendation of the Chief Procurement Officer to extend the current Theatre\ Drama Professional Services Contract with Miami Children's Theatre, pursuant to Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications", until December 31, 2014, and thereafter on a month-to-month basis until the RFP process is completed and a new contract is executed.


SECTION 3. That the City Commission does hereby authorize the City Manager to execute an extension of the Contract with such modifications to the form attached hereto as Exhibit "A" as may be approved by the City Manager and City Attorney that are necessary to implement the intent of this Resolution.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
