**RESOLUTION NO. 2024-**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE AND EXECUTION OF GRANT AGREEMENT NO. DA-CG-24-294 FROM THE FLORIDA INLAND NAVIGATION DISTRICT (FIND) WATERWAY ASSISTANCE PROGRAM IN THE AMOUNT OF \$125,000 FOR THE ACQUISITION OF A MARINE PATROL VESSEL AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT FOR SAID FINANCIAL ASSISTANCE; AND AUTHORIZING AN AMENDMENT TO FISCAL YEAR 2024-2025 ANNUAL BUDGET TO RECOGNIZE THE GRANT FUNDS AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE COST OF THE GRANT EXPENDITURES

**WHEREAS**, on May 7<sup>th</sup>, 2024, the City Commission authorized the City Manager to execute a resolution for assistance with the Florida Inland Navigation District (the District), for the acquisition of a Marine Patrol Vessel; and

**WHEREAS**, the District agreed to provide said financial assistance for the acquisition of an additional Police Marine Patrol Vessel to patrol the intracoastal waterways of the City of Coral Gables and Biscayne Bay; and

**WHEREAS**, The City received the competitive grant in the amount of \$125,000, with a \$215,000 match from the City, resulting in a total project cost of \$340,000; and

**WHEREAS**, an amendment to the Fiscal Year 2024-2025 annual budget is required to recognize the grant funds in the amount of \$ 125,000 as revenue and to appropriate such funds to cover the cost of the grant expenditures; and

**NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** That the foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** That the City Manager is authorized to execute agreement no. DA-CG-24-294 with the Florida Inland Navigation District for financial assistance in the amount of \$ 125,000.

**SECTION 3.** The City Commission does hereby authorize an amendment to the Fiscal Year 2024-2025 annual budget to recognize the grant funds as revenue and to appropriate such funds to cover the cost of the grant expenditures.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
