RESOLUTION NO. 2020-260

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE GYMNASTIC CENTER PROGRAM MANAGEMENT SERVICES CONTRACT TO TUMBLE BEES GYMNASTIC, INC., THE HIGHEST RANKED RESPONSIVE-RESPONSIBLE PROPOSER, PURSUANT TO SECTION 2-763 OF THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD" AND REQUEST FOR PROPOSALS (RFP) 2020-034.

WHEREAS, on October 8, 2020, the Procurement Division of Finance formally advertised, issued, and distributed for Request for Proposals (RFP) 2020-034 for Gymnastic Center Program Management Services; and

WHEREAS, on October 30, 2020, two (2) firms submitted proposals in response to the RFP: Gym Kidz LLC., and Tumble Bees Gymnastic, Inc.; and

WHEREAS, on November 13, 2020, the Evaluation Committee convened to evaluate the two (2) responsive and responsible proposals. The Evaluation Committee determined that Tumble Bees Gymnastic Inc, was the highest responsive-responsible proposer; and

WHEREAS, the Evaluation Committee further recommended that should negotiation fail with Tumble Bees Gymnastic Inc, negotiations could commence with the next proposer; and

WHEREAS, Section 2-585 of the Procurement Code, the City Manager is authorized to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission accepts the recommendation of the Chief Procurement Officer to award the Gymnastic Center Program Management Services contract to Tumble Bees Gymnastic, Inc., the highest responsive-responsible proposer, pursuant to Section 2-763 of the Procurement Code entitled "Contract Award", further authorizing the City Manager to negotiate and execute a Professional Services Agreement for an initial period of

three (3) years with options to renew for two (2) additional one (1) year periods, for an amount not to exceed the available budget ; should negotiations fail, the City will proceed with the next ranked proposer, until an agreement and contract amount is acceptable to the City.

SECTION 3. This Resolution shall become effective upon the date of its passage and adoption herein.


