Mr. Anderson: So this is a resolution just basically, every five years – in 1980 the state passed a statute called Florida Energy Efficiency and Conservation Act and every five years they revisit it. The Public Service Commission revisits it with the utility companies in the State of Florida in establishing energy efficiency goals, and we are coming up on that five year term now and they are going to be meeting in a couple of months; and this is a resolution basically asking the Public Service Commission to work with utilities on adopting higher energy efficiency goals for the utilities. Unfortunately, in the State of Florida compared to the rest of the country, it's a lot lower than most places around the country, so its really pushing the Public Service Commission to work with the utilities in adopting higher energy efficiency goals.

Mayor Valdes-Fauli: Will you make a motion?

Vice Mayor Lago: I just wanted to change one thing, maybe in the resolution that talks about, I want to see if my colleagues are interested in potentially changing the word ambitious to cost effective goals. I want to make sure that its not just ambitious, because its very ambiguous. I want to make sure that its cost effective, because when you talk about cost effective goals, you are talking about not only what's in the best interest of the community as a whole, but also the business community. I want to make sure that its where we are getting right to the core of the issues that, not only about sustainability, its also about saving as much money as possible. And its been proven that solar, obviously works in both accounts.
