## **RESOLUTION NO.**

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD PURCHASE OF MARINE FIRE RESCUE VESSEL TO DGS BOATS, CORP, THE MOST RESPONSIVE AND RESPONSIBLE BIDDER, PURSUANT TO INVITATION FOR BIDS (IFB) 2025-036 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

- **WHEREAS,** on September 17, 2025, the Procurement Division of Finance formally advertised, issued and distributed the IFB for the Purchase of a Marine Fire Rescue Vessel; and
- **WHEREAS**, thirty-seven (37) prospective bidders downloaded the IFB package from Infor, the City's web-based e-Procurement service; and
- **WHEREAS**, on October 17, 2025, four (4) bids were received in response to the IFB 2025-036 from DGS Boats, Corp., Legacy Innovations, LLC, Technology International, Inc., and Tideman Boats US, LLC; and
- **WHEREAS**, the Procurement Division finalized its' due diligence process and confirmed that DGS Boats, Corp., is both responsive to the requirements of the IFB and a responsible bidder.
- **WHEREAS**, the Fire Department concurs with the Chief Procurement Officer's recommendation to award the Purchase of Marine Fire Rescue Vessel to DGS Boats, Corp.; and
- **WHEREAS**, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards.

## NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **Section 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **Section 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to award the Purchase of Marine Fire Rescue Vessel to DGS Boats, Corp., the most responsive and responsible bidder in an amount of \$300,062.00 pursuant to Invitation for Bids (IFB) 2025-036 and section 2-763 of the procurement code entitled "Contract Award".
- Section 3. That this resolution shall become effective upon the date of its adoption herein.
