**RESOLUTION NO. 2025-10**

A RESOLUTION OF THE CITY COMMISSION  
INCREASING THE AWARD AMOUNTS FOR THE  
CITY'S POLICE OFFICER AND FIREFIGHTER OF  
THE YEAR, THE INCREASE OF WHICH WILL BE  
FUNDED BY DONATIONS FROM LEAF AT THE  
CORAL GABLES COMMUNITY FOUNDATION.

**WHEREAS**, each year the City of Coral Gables honors a Coral Gables Police Office of the Year and a Coral Gables Firefighter of the Year; and

**WHEREAS**, the City of Coral Gables currently provides each of the winners of these two awards with a \$1,000 award in honor of their dedication and ongoing commitment to the City; and

**WHEREAS**, the City of Coral Gables is interested in increasing the financial award associated with the Police Officer and Firefighter of the Years awards given by the City; and

**WHEREAS**, LEAF, the Law Enforcement And Firefighter Appreciation Day organization, is a private-sector funded entity managed by the Coral Gables Community Foundation that provides assistance to law enforcement officers and firefighters who have given the ultimate sacrifice, those who have become disabled in the line of duty, and offers scholarship opportunities for their families; and

**WHEREAS**, LEAF also functions as an additional source of funding to ensure first responders are properly equipped to perform their vital duties in protecting the public safety of Coral Gables residents and visitors; and

**WHEREAS**, LEAF is interested in partnering with the City to provide additional financial support to increase the amount of the Police Officer of the Year and the Firefighter of the Year awards to \$5,000 each; and

**WHEREAS**, the City's contribution to these awards will remain at \$1,000 and the increased award amount will be contingent on ongoing donations from LEAF;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the Coral Gables City Commission directs that City staff coordinate with LEAF in order to increase the financial award associated with the Police Officer of the Year and Firefighter of the Year awards.

**SECTION 3.** That the City’s contribution to the financial award for Police Officer and Firefighter of the Year awards shall remain at \$1,000 per award and LEAF commits to provide an annual donation to the City in the amount of \$4,000 per award so long as funds are available.


**SECTION 4.** That the City Commission shall revisit and reconsider the financial award given to the Police Officer and Firefighter of the Year Award winner every five years.

**SECTION 5.** That this Resolution shall become effective upon the date of its passage and adoption herein.


