RESOLUTION 2021-

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD RFQ 2021-008 LANDSCAPING ARCHITECTURAL CONSULTING SERVICES AND NEGOTIATE A PROFESSIONAL SERVICES AGREEMENT (“AGREEMENT”) WITH CALVIN, GIORDANO & ASSOCIATES, INC., CHEN MOORE AND ASSOCIATES, INC., KIMLEY-HORN AND ASSOCIATES, INC., MILLER LEGG AND SAVINO & MILLER DESIGN STUDIO, PA. THE FIVE (5) RESPONSIVE-RESPONSIBLE PROPOSERS, PURSUANT TO FLORIDA STATUTE 287.055, KNOWN AS THE “CONSULTANTS COMPETITIVE NEGOTIATION ACT”

WHEREAS, on June 25, 2021, the Procurement Division of Finance formally advertised, issued, and distributed Landscaping Architectural Consulting Services, Request for Qualifications (RFQ) 2021-008; and

WHEREAS, five (5) firms submitted proposals in response to the RFQ: Calvin, Giordano & Associates, Inc., Chen Moore and Associates, Inc., Kimley-Horn and Associates, Inc., Miller Legg and Savino & Miller Design Studio, P.A.; and

WHEREAS, on September 23, 2021, the Evaluation Committee convened the five (5) responsive proposals and recommended that the City award the RFQ to negotiate a Professional Services Agreement (“Agreement”) with the five (5) responsive-responsible proposers: Calvin, Giordano & Associates, Inc., Chen Moore and Associates, Inc., Kimley-Horn and Associates, Inc., Miller Legg and Savino & Miller Design Studio, P.A.; and

WHEREAS, the Chief Procurement Officer recommends accepting the Evaluation Committee’s recommendation; and

WHEREAS, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to award RFQ 2021-008 for Landscaping Architectural Consulting Services and negotiate a Professional Services Agreement (“Agreement”) with Calvin, Giordano & Associates, Inc., Chen Moore and Associates, Inc., Kimley-Horn and Associates, Inc., Miller Legg and Savino & Miller Design Studio, PA., the five (5) responsive-responsible proposers, pursuant to Florida Statute 287.055, known as the “Consultants Competitive Negotiation Act” in an amount not to exceed the available budget.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
