A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE PURCHASE AND INSTALLATION OF EMERGENCY GENERATOR TO AGC ELECTRIC, INC., THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE TOTAL ESTIMATED AMOUNT OF \$574,505.00, PURSUANT TO INVITATION TO BIDS (IFB) 2025-003 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on March 19, 2025, the Procurement Division of Finance formally advertised, issued and distributed the IFB for Purchase and Installation of Emergency Generator; and

WHEREAS, three hundred forty-eight (348) prospective bidders were notified through INFOR, the City's web-based e-procurement system; and

WHEREAS, on June 3, 2025, four (4) bids were received in response to the IFB: AGC Electric, Inc., Coreland Construction, Corp., Eau Gallie Electric, Inc., and Stonehenge Construction, LLC; and

WHEREAS, the Public Works Department concurs with the Chief Procurement Officer's recommendation to award the Purchase and Installation of Emergency Generator to AGC Electric, Inc; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer authorizing the City Manager to award the Purchase and Installation of Emergency Generator to AGC Electric, Inc, the lowest responsive and responsible bidder in the estimated total amount of \$574,505.00 but not to exceed the available budget, pursuant to Invitation for Bids (IFB) 2025-003 and section 2-763 of the procurement code entitled "contract award".

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
