ITEM TITLE:

A Resolution of the City Commission accepting the recommendation of the Chief Procurement Officer to approve a contract modification to increase the spending authority on the NASPO Value point master contract agreement # 00318 - Public Safety Communication Products, Services and Solutions in the estimated amount of \$4,065,113.19, pursuant to section 2- 764 (b) of the City' s Procurement Code entitled Change Orders and Contract Modifications".

BRIEF HISTORY:

The NASPO ValuePoint Cooperative Purchasing Program conducted a competitive procurement and resulting Cooperative Purchasing Master Agreement for Public Safety Radio. The City accessed the contract awarded on January 1, 2022, on behalf of the City's Police Department (Department) to have the ability to purchase any of the related equipment outlined in the contract.

The Department has the need to replace their existing equipment with new technology that will allow them the ability to continue to provide mission critical technology solutions. The increase in the spending authority for this contract will allow them to purchase Next Generation APX NEXT portable radios with leverage LTE (Long-term evolution) and SmartRadio Technology to improve personnel safety. The APX NEXT platform provides situational awareness through Location Tracking and Mapping of Users, sending of messaging and multimedia between users and enhancing voice communications over LTE Cellular.

The technology solution being purchased will include multi-band radios & accessories; LTE Smart application services, radio programing, smart location services, multimedia communication tool, warranty and accidental damage coverage for seven (7) years.

Under Section 2-764 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications," the spending authority shall be modified in the estimated amount of \$4,065,113.19 to allow for additional funds necessary to address any future needs to complete the project or in an amount not to exceed the available budget.

Fiscal Impact:

New radios will include warranty and accidental damage coverage for the next seven (7) years reducing the costs of the current matrix for repairs of existing radios. A portion of the radios assigned to UM will be reimbursed each year.

Purchasing Next Generation APX NEXT portable radios with leverage LTE (Long-Term Evolution) and SmartRadio Technology to improve personnel safety and provide mission critical technology solutions. The APX NEXT platform provides situational awareness through location tracking and mapping of users, sending of messaging and multi-media between users, CAD, RMS systems, and enhancing voice communications over LTE cellular.
