**RESOLUTION NO. 2026-72**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2025-2026 ANNUAL BUDGET TO RECOGNIZE AS REVENUE \$103,340.00 AND TO APPROPRIATE \$103,340.00 TOWARDS OPIOID AND SUBSTANCE ABUSE EDUCATION, TREATMENT, PREVENTION AND OTHER RELATED PROGRAMS AND SERVICES, PURSUANT TO THE FLORIDA OPIOID ALLOCATION AND STATEWIDE RESPONSE AGREEMENT.

**WHEREAS**, the City Commission adopted Resolution No, 2021-80, authorizing the City to participate in the State of Florida Opioid Settlement, and

**WHEREAS** the City of Coral Gables entered into an Opioid Settlement Interlocal Agreement with Miami-Dade County that outlined, among other things, the proper use of Opioid Settlement funds; and

**WHEREAS**, funds will be distributed over an 18-year period as part of a global settlement; and

**WHEREAS**, since inception of the program, the City has received \$103,340.00 in settlement funds; and

**WHEREAS**, the Police Department and Fire Department have identified education and training programs acceptable under the program use guidelines; and

**WHEREAS**, an amendment to the Fiscal Year 2025-2026 Annual Budget is required to recognize the \$103,340.00 of program funds received to date as revenue and to appropriate such funds to be used for substance abuse education, treatment, prevention and other related programs and services as allowable under program guidelines, and

**WHEREAS**, subsequent year receipts of settlement funds will also be used on programs acceptable under the program guidelines;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption herein.

**SECTION 2.** That the City Commission authorizes an amendment to the FY 2025-2026 Annual Budget to recognize the \$103,340.00 of program as revenue and to appropriate \$103,340.00 towards program expenditures.

**SECTION 3.** That the City Commission authorizes the funds received annually from this program to be appropriated as revenue and towards the program expenditures each year.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


