RESOLUTION NO.

A RESOLUTION APPROVING THE UNIVERSITY OF MIAMI'S 2025 CAMPUS ART MASTER PLAN REPORT IN ACCORDANCE WITH THE REQUIREMENTS OF THE ART IN PUBLIC PLACES ORDINANCE, ZONING CODE ARTICLE 9 (CULTURAL DEVELOPMENT BOARD RECOMMENDATION TO THE CITY COMMISSION APPROVAL/DENIAL VOTE: 6 TO 0).

WHEREAS, on December 11, 2007, the City Commission enacted Ordinance No. 2007-37, creating an Art in Public Places Ordinance, amended most recently on August 26, 2025 and codified in the City of Coral Gables Zoning Code as Article 9 – Art in Public Places; and

WHEREAS, Article 9, Section 9-103.C.4. an exemption is made for an accredited college and/or university that maintains at its campus a publicly accessible permanent collection of art of at least thirty (30) sculptures and/or other public art in accordance with a Campus Art Master Plan; and

WHEREAS, on May 13, 2008; December 14, 2010; December 10, 2013, January 10, 2017, December 10, 2019, and June 13, 2023, the City Commission passed Resolutions finding the University of Miami Campus Art Master Plan sufficient in meeting the requirements of the Art in Public Places Ordinance; and

WHEREAS, the aforementioned exemption requires that a report of the Campus Art Master Plan, demonstrating changes to the collection of art on the campus during the previous three-year interval shall be made to the City Commission; and

WHEREAS, On November 19, 2025 the Cultural Development Board voted unanimously to recommend approval of the University of Miami's Campus Art Master Plan as presented.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "Whereas" clauses are here hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby accept and approve the University of Miami's Campus Art Master Plan report for the period between December 2025 and December 2028 in fulfillment of the Art in Public Places requirement.

SECTION 4. That this resolution shall become effective upon the date of its passage and adoption herein.
