The Florida League of Mayors and the Florida League of Cities sponsor an annual contest open to all 7th graders in a Florida public and private school, as well as Florida homeschooled students to write an essay that begins with the statement, "If I were elected Mayor . . ." of not more than 250 typed words long and fitting on one page. In the essay, students must describe how they would make a difference as Mayor to make their city the best place to live. Contest winners receive the following: the first place winner will receive a \$100 gift card and have a chance to be "Mayor for a Day" in their city; the second place winner will receive a \$50 gift card, while the third place winner will receive a \$25 gift card. First, second and third place winners will receive a joint resolution from the Florida League of Mayors and the Florida League of Cities, to be presented by the Mayor at a hometown City Commission meeting].

The Florida Department of Health recognized 98 communities as the "2017 Healthy Weight Community Champions" with Coral Gables being one of those communities recognized. Florida's county and municipal governments play an important role in decreasing the prevalence of unhealthy weight in their jurisdictions. Local governments can implement a variety of policies that have been shown to increase physical activity and improve nutrition. These best practice policies are reflected in the "Healthy Weight Community Champion" submission criteria. Local governments were invited to submit best practices they have implemented in their jurisdictions.

The City of Coral Gables was recognized as a "Healthy Weight Community Champion" for 2017), because it encourages its citizens to engage in more active and healthy lifestyles. The Coral Gables Farmers Market, now in its 26th season, was cited as it is designed as a small outdoor European-style green market near City Hall, with South Florida produce available at the market, as well as healthy baked goods and gourmet specialty foods. The City also has a streetscape project and the goal of the project is to enhance the economic vitality of the downtown district by transforming the City's main street, Miracle Mile and Giralda Avenue to provide a cohesive pedestrian-friendly experience with garden areas, outdoor dining, improved lighting, wayfinding, public art and more].

[Note for the Record: Following Mayor Valdes-Fauli's reading of the title to Agenda Item 4 (i.e. Presentation of a Proclamation declaring May 2017 as "National Water Safety Month" in Coral Gables), Commissioner Quesada read the Proclamation and presented it to Parks and Recreation Director Fred Couceyro and Assistant Parks and Recreation Director Carolina Vester. City Manager Swanson-Rivenbark also recognized the Parks and Recreation Department for receiving the "Platinum International Aquatic Safety Award" from Ellis and Associates (E & A).

The proclamation recognizes May as "National Water Safety Month" and recognizes both staff and volunteers of the Venetian Pool in the prevention of drowning and education of water safety. The Parks and Recreation Department was also awarded the prestigious "Platinum International Aquatic Safety Award", which demonstrates that the Venetian Pool consistently exceeds industry standards in risk management and epitomizes aquatic safety excellence. This is the fourth consecutive year that the Venetian Pool and its staff have received the "Platinum International Aquatic Safety

Award”.

The International Aquatic Safety Awards are presented annually to participants in the Ellis & Associates’ “Comprehensive Aquatic Risk Management Program” (CARMP) and are based on the results of multiple random unannounced aquatic facility operational safety audits throughout the year. These audits include undercover video surveillance of individual lifeguards, in order to accurately evaluate their professional diligence. Additionally, individual and team basic life support and rescue skills are evaluated, along with simulated emergencies that measure the effectiveness of established Emergency Action Plans. Presented in three levels - Silver, Gold, and Platinum - only the top 10 percent of E&A clients achieve a “Platinum International Aquatic Safety Award”].

[Note for the Record: Following Mayor Valdes-Fauli’s reading of the title to Agenda Item 5 (i.e. Presentation of the 2016 Florida Police Chiefs Association “Lifesaving Award” (for the period of July-December, 2016) for the "State of Florida, and the Coral Gables Police Department “Silver Medal of Valor Award," for Officer’s Nestor Chavez, Kristopher Clute, Nayel Medina, Alex Jorva, and Daniel Sotolongo, along with Sergeant’s Alex Escobar, Jesus Garcia and Paul Koppel), the 2016 Florida Police Chiefs Association “Lifesaving Award” was presented to Mayor Valdez-Fauli and Chief Hudak by a representative of the Florida Police Chief’s Association, and the “Silver Medal of Valor Award” were presented by Mayor Valdez-Fauli to the above Police Officers and Police Sergeants.

The awards were presented as a result of an incident that occurred on October 14, 2016, in which Officer’s Nestor Chavez, Kristopher Clute, Nayel Medina, Alex Jorva, and Daniel Sotolongo, along with Sergeant’s Alex Escobar, Jesus Garcia and Paul Kopple encountered a 54 year old male in a crisis state of mind that had attempted to end his life. At 12:35 hours, the Officers and Sergeants arrived to the

2700 Block of Lejeune Road after the Coral Gables Police Communication Center received several 911 calls about a man covered in blood displaying a knife while walking in traffic. The officers and Sergeants positioned their marked units in the northbound lanes taking tactical positions pointing their duty handguns at the male and giving verbal commands to "Drop the knife!" The male continued to ignore the verbal commands and began to close the distance as he walked toward the officers. The Officers elected to transition to a less lethal weapon in an attempt to safely stop the male from harming himself, innocent bystanders or the officers themselves. The Taser was deployed several times as loud verbal commands were given to drop the knife. The male then dropped the knife and was immediately restrained by the officers and administered first aid by the police officers on scene followed by Coral Gables Fire Rescue personnel. Because of the action of the officers, the Florida Police Chief Association awarded the Coral Gables Police Officers and Sergeants the 2016 "Lifesaving Award" for the period of July-December 2016. The Coral Gables Police Department also awarded these officers and sergeants the "Silver Medal of Valor" for their actions on October 14, 2016].
