**RESOLUTION APPROVING A MEMORANDUM OF  
UNDERSTANDING BETWEEN THE CITY OF CORAL  
GABLES AND UNIVERSITY OF MIAMI POLICE  
DEPARTMENT FOR UNIVERSITY OF MIAMI POLICE  
DEPARTMENT TO JOIN THE CITY'S FIBER  
INSTITUTIONAL NETWORK OPERATIONS.**

**WHEREAS**, by Ordinance No. 3278, passed in October 1997, and by Ordinance 2004-50, passed December 2004, the City has established a cable television franchise agreement whereby all governmental authorities, schools, or persons designated by the City are interconnected by an Institutional Network (I-Net); and

**WHEREAS**, University of Miami Police Department (UMPD) is one of those locations identified to be connected to the I-Net; and

**WHEREAS**, UMPD is a public safety organization operating as a sub-agency to the City of Coral Gables Police Department (CGPD); and

**WHEREAS**, the connection to the I-Net is considered a special public safety connection in support of mission-critical applications such as Computer Aided Dispatch (CAD) and Records Management System (RMS); and

**WHEREAS**, this special I-Net connection to the CGPD public safety network, called a PS-Net, provides UMPD with a high speed connection, dramatically increasing speed and reliability; and the connection further increases productivity for UMPD staff enabling them to provide enhanced services to campus personnel, staff and the student body; and

**WHEREAS**, UMPD intends to use the PS-Net connection for Public Safety and institutional purposes and agrees that they will comply with the terms and condition of the MOU for a three-year term; and

**WHEREAS**, the City of Coral Gables will provide UMPD with a high speed connection through the PS-Net shared fiber network; and the fiber that provides the PS-Net connectivity was installed and is operated at the sole expense of the cable television franchisee; and the electronics that will be used to provide the connectivity at the UMPD location will be purchased, installed and maintained by the City; and

**WHEREAS**, UMPD will compensate the City for all equipment, connection, installation and maintenance with payments of \$365 per month for a three (3) year period at a sum of \$13,140;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF  
THE CITY OF CORAL GABLES:**

**SECTION 1.** The forgoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption herein.

**SECTION 2.** That the City Commission does hereby authorize the City Manager to adopt the attached Memorandum of Understanding and that the City enables University of Miami Police Department to connect to the City’s fiber Institutional Network Operations and use the connection for Public Safety and institutional purposes, and will comply with the terms of the MOU for a three (3) year term.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
