

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2021-202**

A RESOLUTION OF THE CITY COMMISSION AMENDING THE FISCAL YEAR 2020-2021 AMENDED ANNUAL BUDGET TO RECOGNIZE AS REVENUE MUNICIPAL, MOBILITY AND POLICE IMPACT FEES, AND TO APPROPRIATE SUCH FUNDS TO PUT TOWARD THE MINORCA GARAGE CONSTRUCTION AND TROLLEY BUILDING/PSAP EMERGENCY GENERATOR PROJECTS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, in compliance with Ordinance 2007-27 as well as the revised impact fee schedule as approved by Resolution 2017-67, the City collects various impact fees to help fund capital improvement projects that qualify as enhancing services for residents, business owners and visitors; and

**WHEREAS**, as of June 1, 2021 impact fee availability for Municipal, Mobility and Police improvements are available for appropriation in the amounts of \$201,478, \$575,792, and \$81,605, respectively; and

**WHEREAS**, staff recommends appropriating the identified Municipal and Mobility impact fees totaling \$777,270 (\$201,478 + \$575,792) to put toward the Minorca Garage project (Garage 7) in order to free up less use restrictive General Capital Improvement/Parking fund dollars; and

**WHEREAS**, staff recommends appropriating the identified Police impact fees of \$81,605 to put toward the current Trolley Building/PSAP emergency generator project; and

**WHEREAS**, an amendment to the Fiscal Year 2020-2021 Annual Budget is required to recognize as revenue the aforementioned Municipal, Mobility and Police impact fees and to appropriate such funds to put toward the Minorca Garage construction and Trolley Building/PSAP Emergency Generator projects;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


**SECTION 2.** The City Commission authorizes an amendment to the Fiscal Year 2020-2021 Annual Budget to recognize as revenue the available Municipal, Mobility and Police impact fees and to appropriate such funds to put toward the Minorca Garage Construction and Trolley Building/PSAP Emergency Generator projects.

**SECTION 3.** All Resolutions or parts of Resolutions, insofar as they are inconsistent or in conflict with the provisions of this Resolution, are hereby repealed.


**SECTION 4.** This Resolution shall become effective upon the date of its passage and adoption herein.


