At the next available City Commission Meeting, an award recommendation for RFP 2021-032 Medical Director Services will be included on the agenda. This memorandum serves to notify you that in accordance with Section 2-763 of the City Code entitled "Contract Award", my recommendation to the City Commission for award of the subject RFP is as follows:

- 1) Accept the recommendation of the Chief Procurement Officer to award the RFP and authorize negotiations with InPhyNet South Broward, Inc, a responsive and responsible bidder, for the purchase of Medical Director Services.
- 2) Reaffirm the City's right to pursue alternative course of action.

On October 5, 2021, the Procurement Division of Finance formally advertised, issued, and distributed Medical Director Services, Request for Proposals (RFP) 2021-032. Seventeen (17) prospective proposers downloaded the RFP package from Public Purchase, the City's web-based e-Procurement.

On November 4, 2021, one (1) firm submitted its proposal in response to the RFP: InPhyNet South Broward, Inc.

The response was reviewed by the Procurement Division to determine responsiveness to the requirements of the RFP.

On January 28, 2022, the Evaluation Committee convened to evaluate the proposal. The Evaluation Committee determined that InPhyNet South Broward, Inc., is a responsive-responsible proposer

After successful negotiations, A Professional Services Agreement will be executed. A more detailed description of the RFP, responses and evaluation results will be provided to you as part of the agenda package.
